High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are working with National Highways on our next phase of works which include a planned demolition of the A446/A452 Overbridge in summer 2025. This bridge is not in use and has been replaced, as part of the highway upgrades, that will connect to the new HS2 station for Solihull.

Before we can progress with the demolition of the bridge we will undertake preparatory works. To complete these works safely the following traffic management is required.

A446/A452 northbound carriageway overnight closure

- From 10pm Tuesday 22 April to 6am Wednesday 23 April 2025 (following this closure, a lane will remain closed until 20 June 2025)

A446/A452 southbound carriageway overnight closure

- From 9pm Wednesday 23 April to 6am Thursday 24 April 2025 (following this closure, a lane will remain closed until 20 June 2025)

Access to Packington Lane during the overnight full carriageway closures will be via the diversion routes.

Duration of works

A446/A452 northbound carriageway overnight closure:

- From 10pm on Tuesday 22 April to 6am Wednesday 23 April 2025

A446/A452 southbound carriageway overnight closure:

- From 9pm Wednesday 23 April to 6am Thursday 24 April 2025

Following these overnight closures a single lane will remain closed on the northbound and southbound carriageways until Friday 20 June 2025.

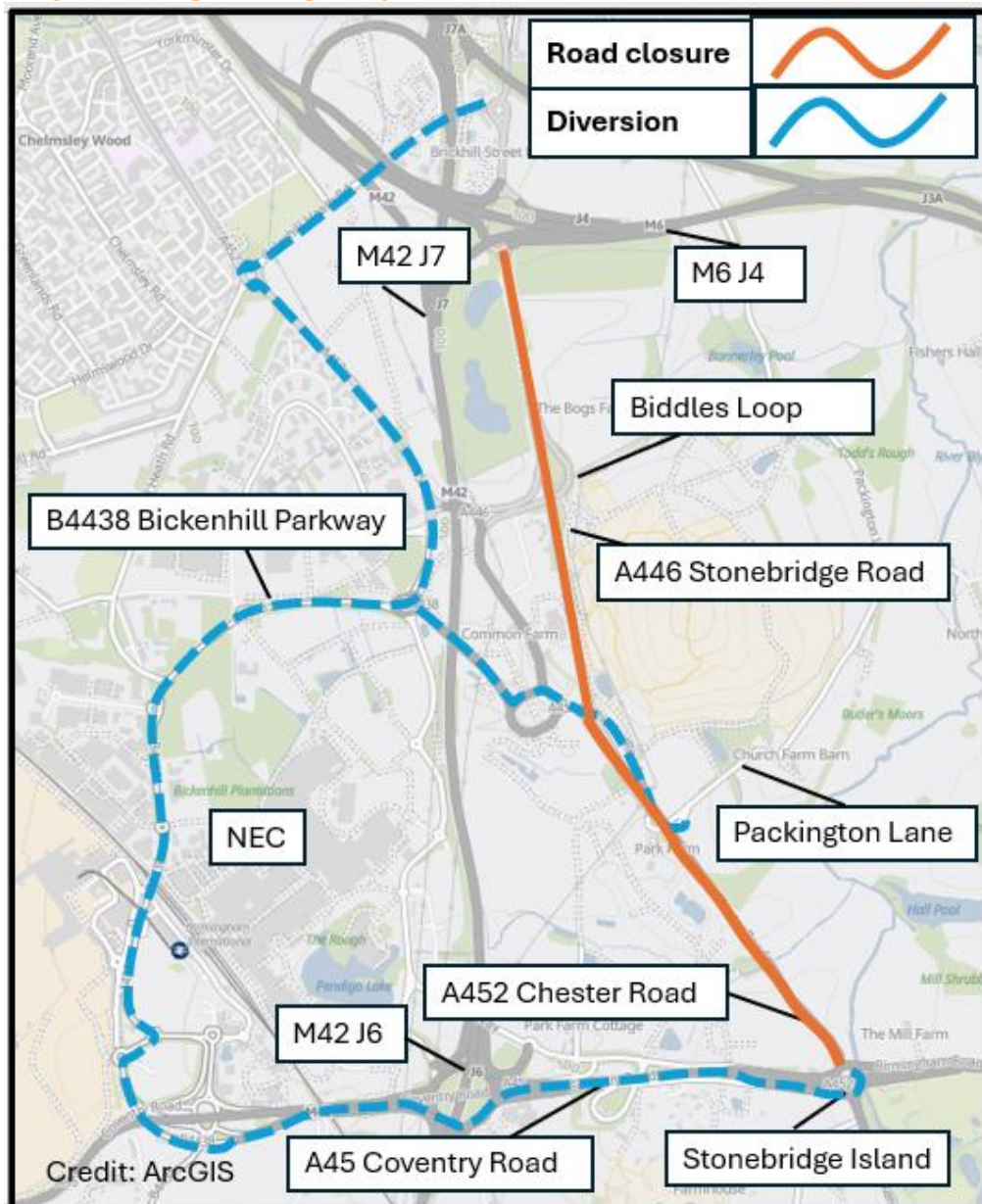
A452 Chester Road northbound diversion route

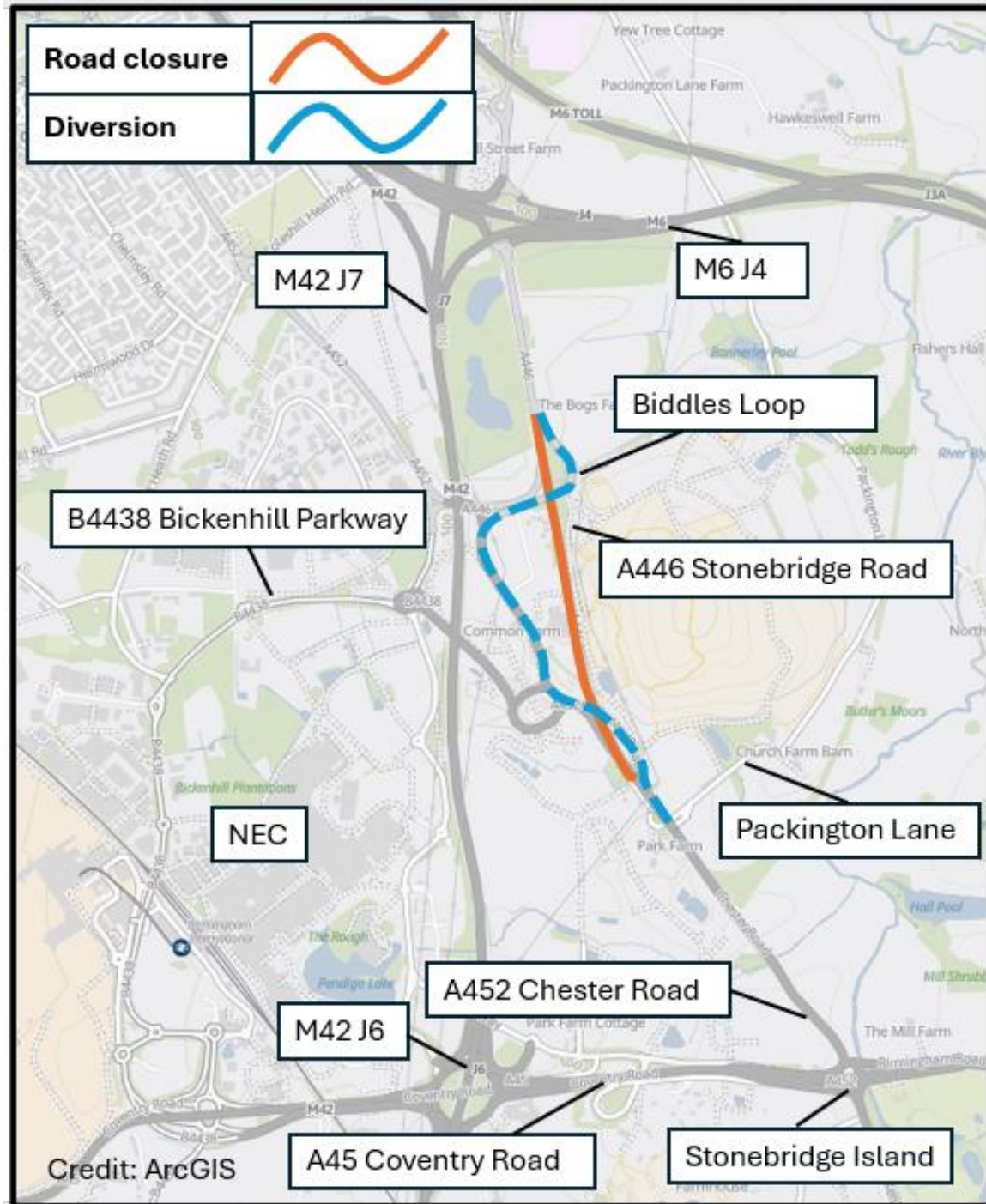
A446 Stonebridge Road southbound diversion route

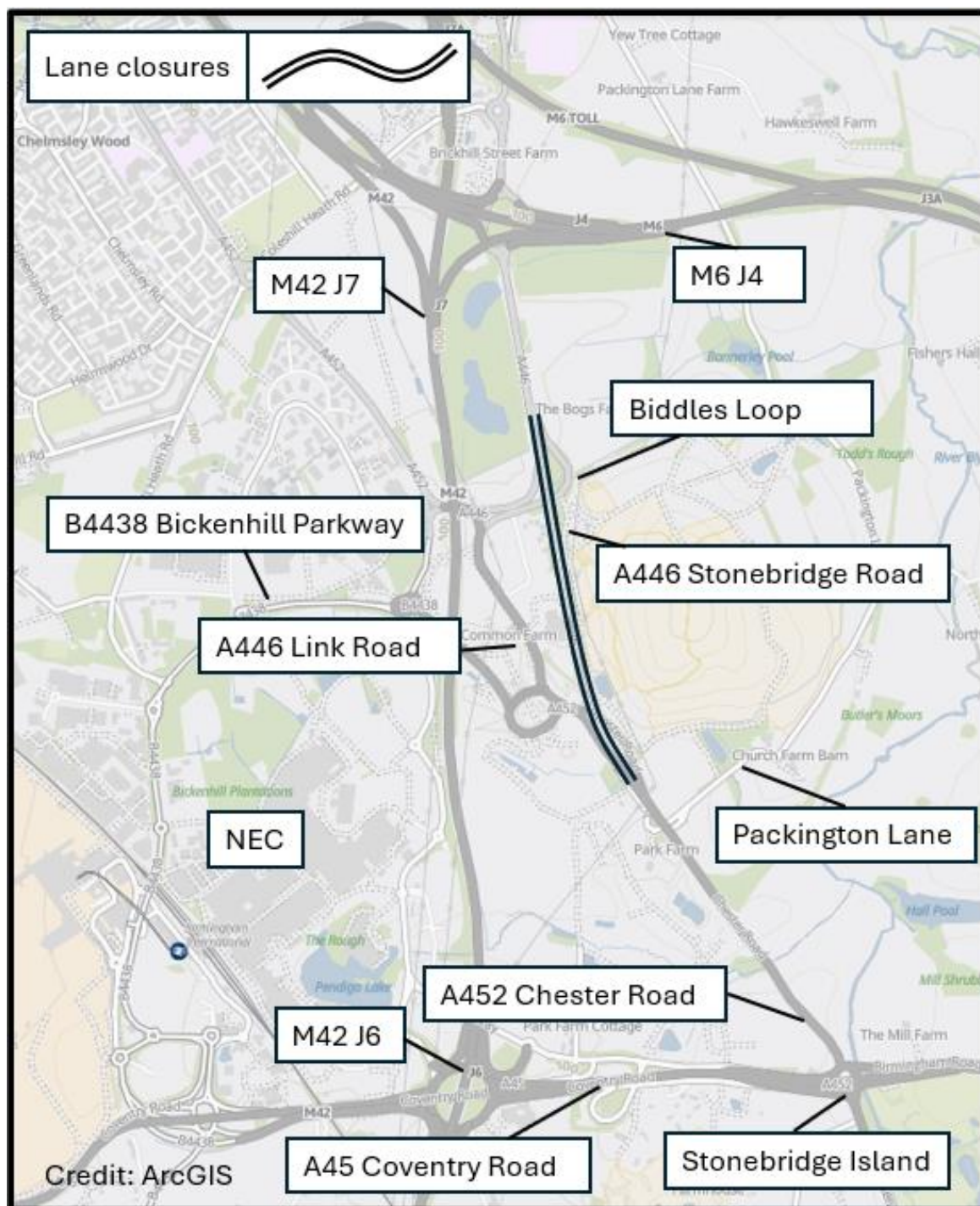
A446/A452 single lane closures
