Notice of Drainage work on the B4118, Birmingham Road

High Speed Two (HS2) is the new high speed railway for Britain. We are writing to make you aware of work that will be undertaken by National Grid on behalf of HS2.

What we are doing

To complete construction of new 132kV Substation (Bromford BSP) National Grid Electricity Distribution (NGED) have installed a drain to serve the facility, for removal of excess rainwater. For the drain to be fully adopted and maintained by Severn Trent Water (STW), a full survey and some remedial works are required to be carried out

To improve traffic flow, we have divided the area into seven shorter sections on the B4118. NGED will have a specialist team working one section at a time (see detail on next page) completing one area before moving on to the next and working towards the Substation.

NGED will undertake the survey and remedial work over ten days between 13 and 23 of May 2025

How will this affect me?

- Access to property frontages shall be maintained throughout the works.
- Temporary bus stops will be installed where required and be located close to the existing stop.
- Temporary traffic lights will be installed to regulate traffic flows at each section and move as the work progresses.
- Traffic Lights will be manually operated at peak times, if required, to avoid significant build-up of traffic in either direction.
- Traffic lights will be set up each day and removed after each shift.
