# Notice of Road Closure, Shipton Lee Road, Quainton

## What are we doing?

In April 2025 we will be closing a section of Shipton Lee road to form part of the Edgcott Road realignment. These works are to construct two bell-mouths and will include highways construction and drainage installation.

To carry out these works safely and effectively we will need to put in place a road closure with signed diversions. Our teams will be working in open trenches on and around carriageway.

## When will these works take place?

A section of Shipton Lee Road will be closed from 22 April until 20 May 2025.

These dates may be subject to change due to circumstances outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes or updates.

A section of Shipton Lee Road will be closed from 22 April until 20 May 2025.

Respond promptly to any complaints and take appropriate action.

Provide a full diversion route for road users.

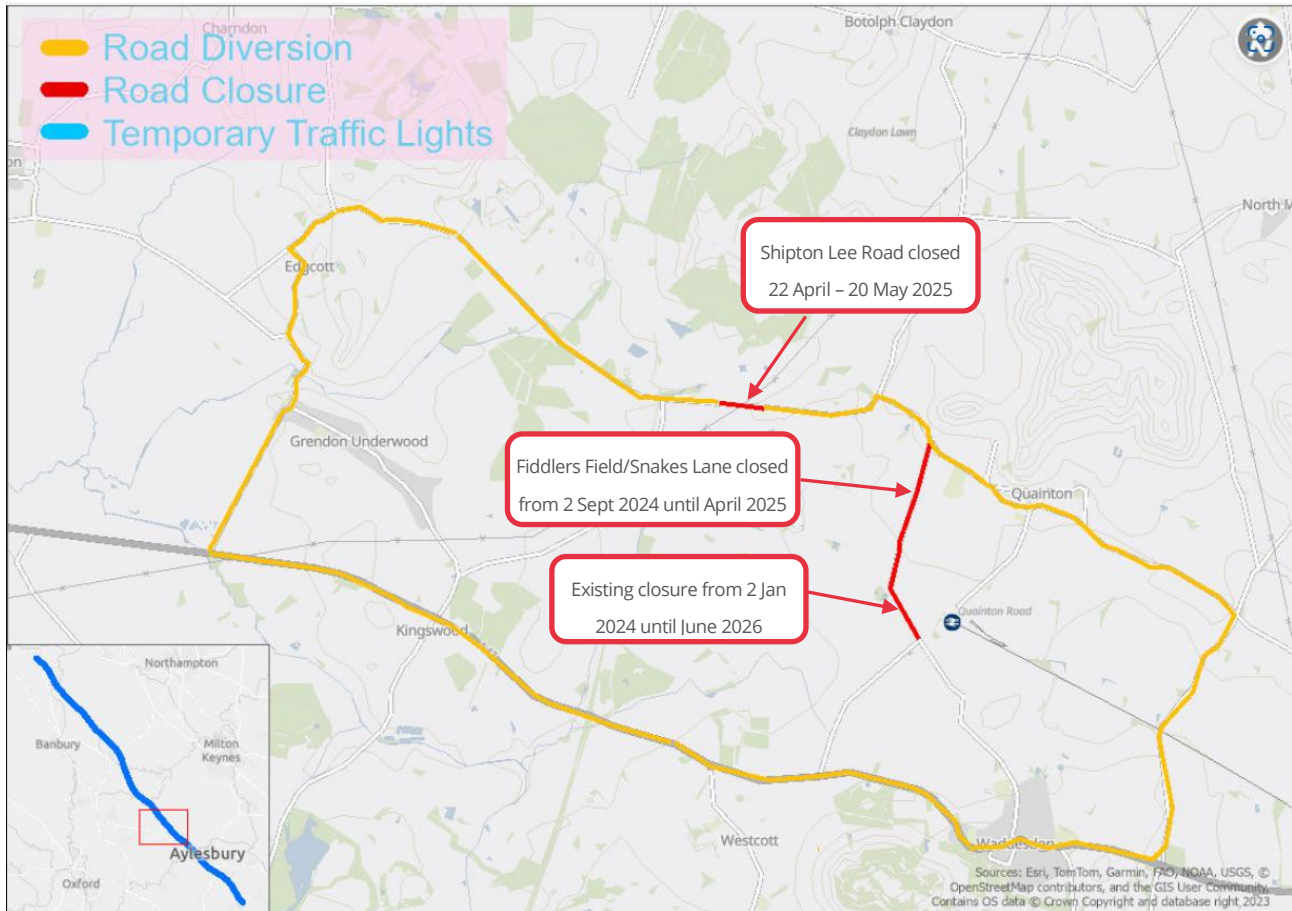
