# **Notice of overnight lane** closures on Lawley **Middleway - Birmingham**



High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

The new railway will approach Birmingham City Centre on a series of viaducts and bridge structures, crossing over roads, existing railways and canals. The railway will cross over the city's ring road at Lawley Middleway between Garrison Circus and Curzon Circus. To minimise disruption to road users this bridge is being constructed next to the road and will be pushed over the ring road later this year. (we will communicate about this separately).

To prepare for this considerable engineering operation we will need to examine the road below by drilling a series of trial holes. In order to do this safely we will need to close a lane either side of the central reservation. To avoid unnecessary disruption this work will be done at night only, between 9pm and 5am from 28 April for three weeks.
