The work we will be doing

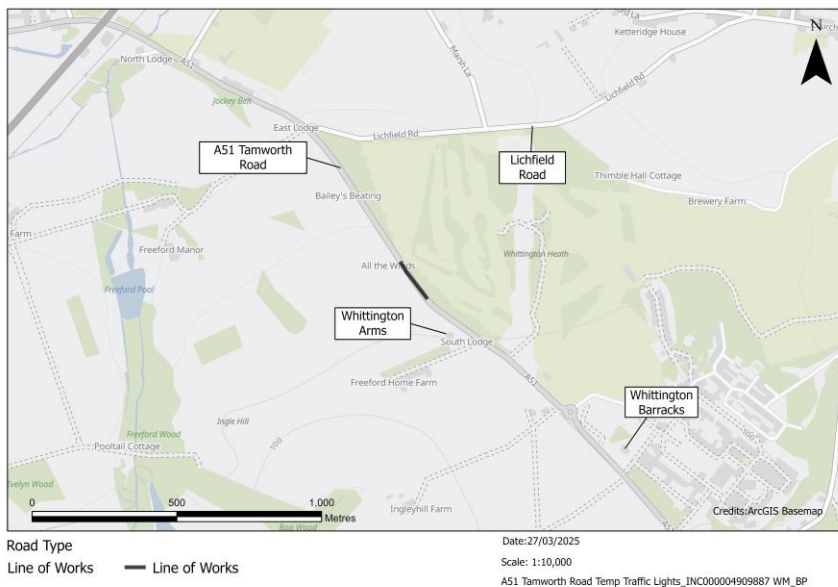
As we continue with preparatory works to build the A51 Tamworth Road bridge that will take HS2 trains underneath the road, we need to complete topographical surveys of the surface of the carriageway.

When the work will take place

To complete our works safely, we will install daytime temporary two-way traffic lights on Tuesday 22 April to Wednesday 23 April 2025 9.30am to 3.30pm
