# Update: utility works on College Crescent, South Hampstead

High Speed Two (HS2) is the new high speed railway for Britain.

### **Extended work hours**

We wrote to you in July to let you know that we will be carrying out works to divert the gas main in South Hampstead from 21 July 2025 to 17 July 2026. Phase one of these works, on College Crescent, is ongoing until **21 September 2025**.

Our core working hours are from 8am to 6pm Monday to Friday, and from 8am to 1pm on Saturdays.

On some Saturdays we may need to work extended hours, from 8am until 6pm. During the extended hours we will keep noisy works to a minimum.

### **Bus stop suspension - phase one**

During phase one, **bus stop G on College Crescent is suspended**. Bus stop F on College Crescent will remain open.



### **College Crescent – works ongoing until 21 September 2025**

We have extended our work area on College Crescent by about 20 metres. This is to allow our vehicles to safely enter and exit the site from Avenue Road. We cannot enter the site via College Crescent due to unrelated emergency utility works at that location. This is not expected to have any additional impact on traffic flow. We have updated the cyclist diversion as shown on the map below.

## **About our Community and Business Funds**
