



Updated notice of overnight closures of A452 Kenilworth Road southbound carriageway, Meriden

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

The new railway will pass under A452 Kenilworth Road between the Meriden Road roundabout and Bradnocks Marsh (Aston Martin) Roundabout.

We are currently completing utility diversion works along the verges using lane closures. We will now undertake resurfacing works, including line markings in the carriageway, and also install a safety barrier to close off lane one.

We recently communicated a programme of overnight closures between 2 May through to 16 May. Please see below the revised dates for these closures which include a reduction in the number of overnight closures.

To complete these works safely we will install overnight closures of the A452 southbound carriageway. During each overnight closure, if the works are completed ahead of schedule, then we will reopen the carriageway earlier than 6am.

When revised closure dates

The overnight closures will be in place from 8pm to 6am on the following dates:

Diversion route for the A452 southbound closure

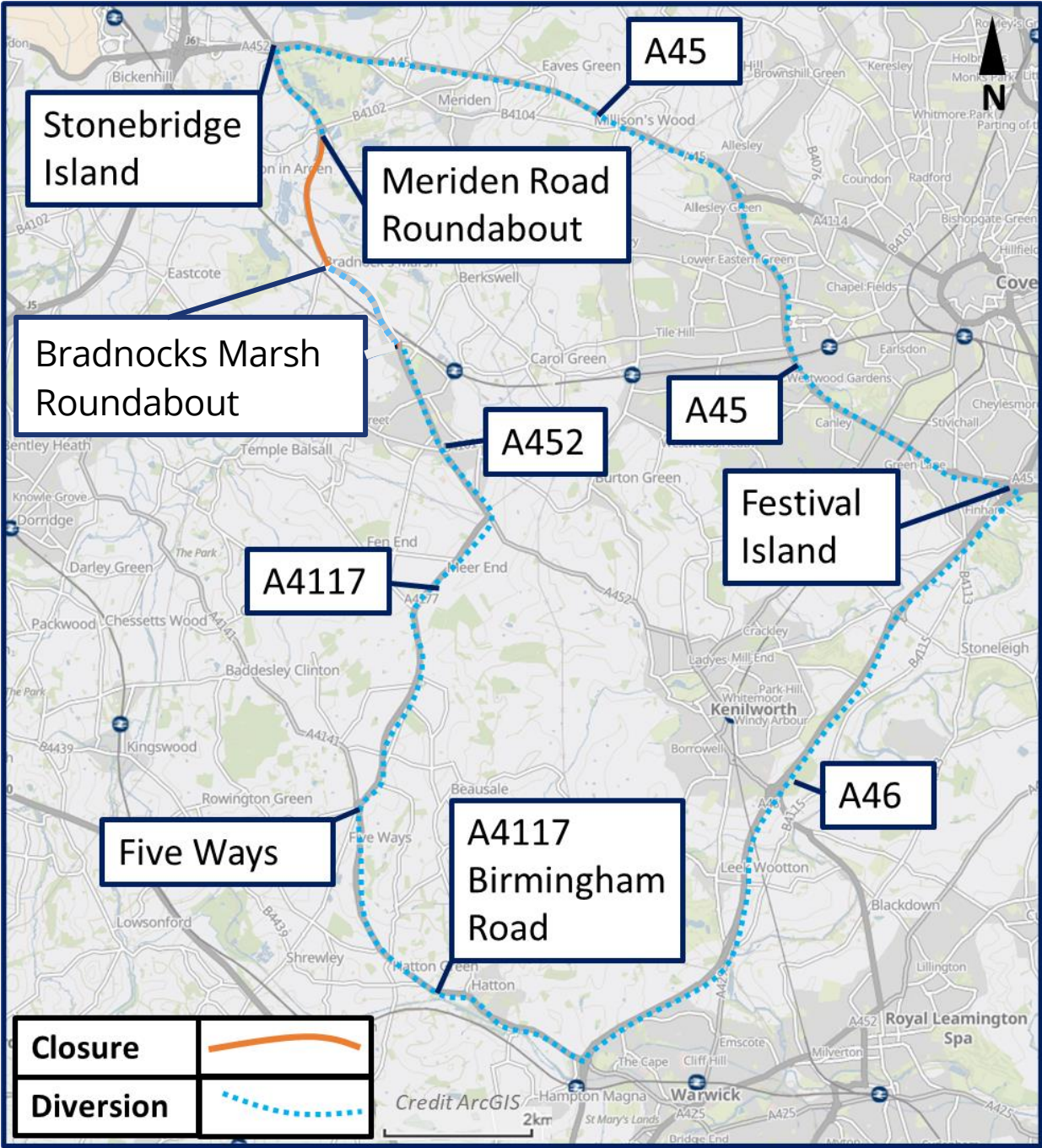
