



# Updated Notice, A5 Hints Bypass & Watling Street

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

We will be re-commencing construction of the Overbridges that will allow HS2 to pass under A5 Hints Bypass and Watling Street. On the A5 this will require our contraflow system to remain in place. On Watling Street, we will begin to use the plant crossing to ensure the safe crossing of large vehicles. Once we have completed our piling works, we will begin the construction of the structures at both locations. Our intended completion date is Spring 2027.

## When will these works be taking place

We will begin our works 23 April at both locations. At Watling Street this will include the use of the plant crossing. On completion of construction works at both locations the traffic measures will be removed and the temporary realignment of both A5 and Watling Street will return to their previous alignments.


