

Notice of borehole works, Gloucester Avenue, Primrose Hill

High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

On **Tuesday 3 June 2025** we will be carrying out two borehole surveys nearby no. 44 and 183 on Gloucester Avenue in Primrose Hill. We will be lifting the manhole covers to take some measurements and photographs of the boreholes beneath.

From **23 to 24 June 2025** we will fill in the borehole outside 183 Gloucester Avenue with concrete. We will place barriers around the borehole. It will take up to three hours to pour the concrete and tarmac each day. The barriers will stay in place until **25 June 2025** to allow the concrete and tarmac to set.

How might this affect you

We will need to suspend up to two parking bays around each borehole for each piece of work. There may be some noise when we fill the borehole with concrete.

We apologise for any disruption this may cause.
