High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

As part of the ongoing preparations for the HS2 railway construction, we will be carrying out essential construction works to return the B4114 Birmingham Road to its original realignment. Traffic management will be installed on the section between the A446 Stonebridge Road roundabout and the Manor Drive roundabout.

### When the work will take place

To ensure the safety of our workforce and road users, a lane closure will be installed on Saturday 24 May from 07:30am to 14:00pm.
