High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As part of our ongoing construction work on the M42/M6 Link Road Viaducts, we will be extending the existing long-term traffic management measures on the eastbound carriageways of the M42/M6 Link Road.


On the eastbound carriageway, the hard shoulder will remain closed from the M6 southbound at Junction 4A to the M42 (both northbound and southbound). A temporary 50mph speed limit will also remain in place for the duration of these works.

When the work will take place

To ensure the safety of the road users and our workforce, the long-term traffic management will be in place from 1 June 2025 until 31 December 2027.
