High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

On **Monday 2 June 2025** we will be carrying out a borehole survey on Mortimer Place.

We will be lifting the manhole cover to take some measurements and photographs of the borehole beneath.

The work will take place for an hour between 8am and 6pm.

How these works might affect you

We will suspend two parking bays as shown on the map below.

We will reopen the parking bays once we have completed the surveys.

This work will not be noisy.
