
On **Thursday 5 and Friday 6 June 2025** we will carry out a CCTV survey within the sewer on Eastcote Lane. This is to check the condition of the sewer further to tunnelling in the area.

We will access the sewer through a manhole in the road. We will then insert a camera to survey the condition of the sewer. We may need to wash the sewer with a jet washing machine to improve visibility for the camera.

#### How this may affect you

You may hear some noise if we need to jet wash the sewer. We will use noise reducing barriers where possible.

The footpath opposite 120 to 134 Eastcote Lane will be suspended from 8am on 5 June until 6pm on 6 June 2025. There will be a pedestrian diversion in place, shown on the map below.
