High Speed Two (HS2) is the new high speed railway for Britain.

## Substation removal works on Victoria Road

From **Wednesday 4 June to Saturday 28 June 2025**, we will be removing a substation within our Victoria Road Crossover Box site, during core working hours.

# What to expect

We will need to narrow the vehicle lanes and there will be a footpath closure for these works. A pedestrian diversion route will be in place on this section of Victoria Road between School Road and Victoria Road.

Traffic management will be in place at all times during these works.

You may hear noise from machinery, such as an excavator, and hand tools. We will aim to minimise disruption where possible.

The map below shows the works area, footpath closure and pedestrian diversion route on Victoria Road.
