High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we are doing

The new high-speed railway for Britain and Interchange railway Station are being built near Birmingham Business Park, Resorts World and the NEC in Solihull.

As part of our planned preparatory works for Coleshill Heath Road Overbridge, we need to carry out drainage surveys and some low-level vegetation clearances on Coleshill Heath Road.

To ensure we complete these activities safely we will install the following overnight closures:

- Monday 16 June 2025 between 8pm and 6am
- Wednesday 18 June 2025 between 9pm and 6am

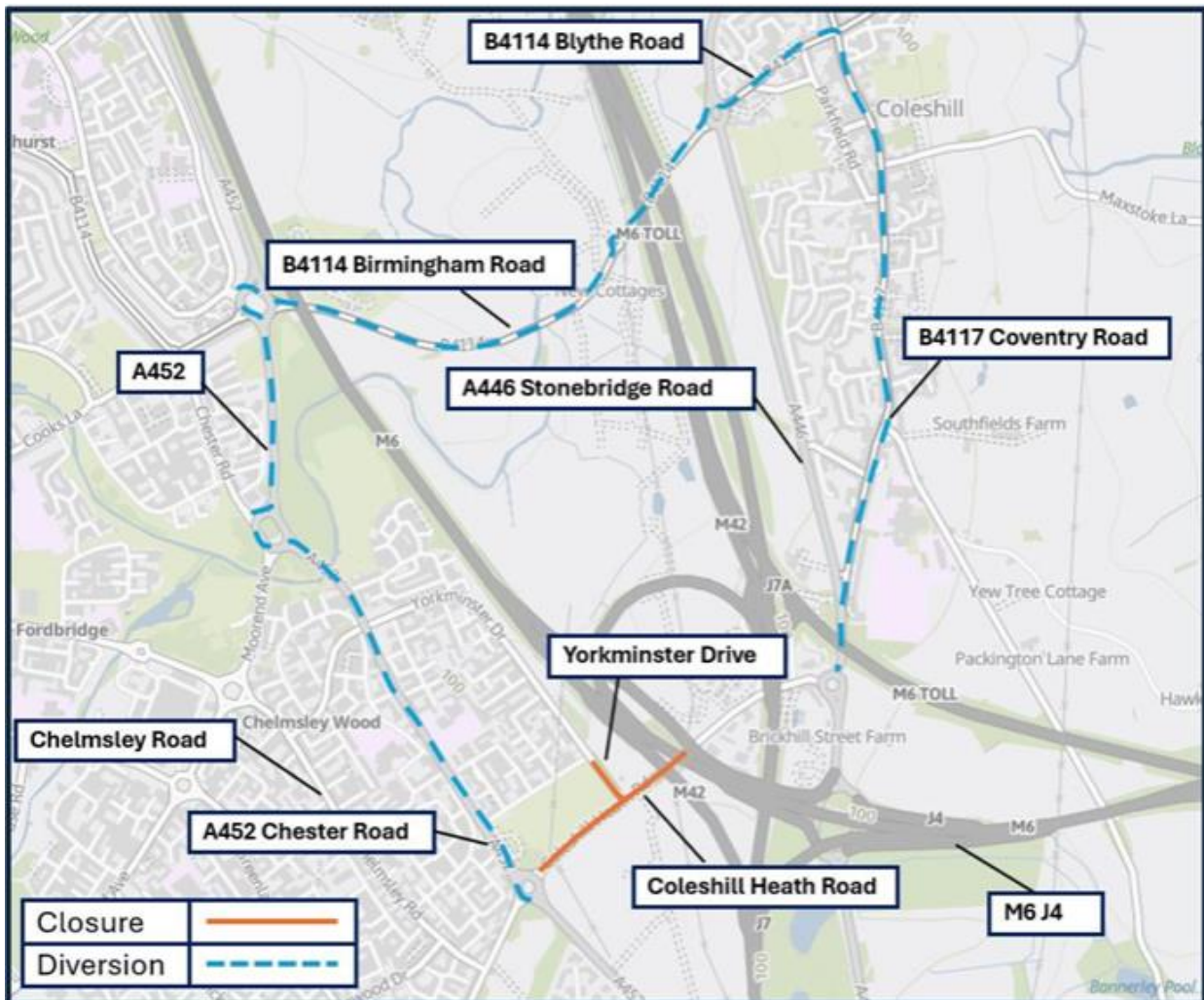

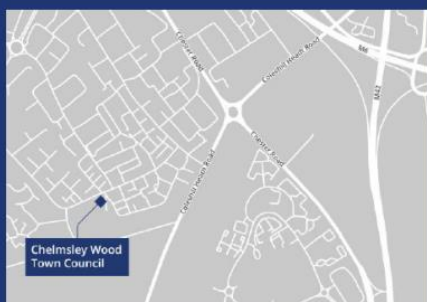
