



# Notice of temporary A452 Chester Road overnight closure – near Bickenhill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

As we progress construction of the M42 motorway box structure we need undertake some upgrades to our A452 Chester Road compound access and install a safety barrier.

To safely carry out our works the following overnight closures are required:

### A452 Chester Road:

Monday 2 June 2025 between 8pm to 6am.

We have booked a contingency closure if we are unable to complete the works during this closure.

The contingency overnight closure, if required, will be Tuesday 3 June 2025 between 8pm and 6am.

### Birmingham Business Park access:

Access to Birmingham Business Park will be via Bickenhill Parkway during these overnight closures.

These works are subject to consent.


# A452 Chester Road – northbound diversion


# A452 Chester Road – southbound diversion
