What are we doing?

General Verge Works - in June and July, we will be working along Blackgrove Road (North). This will be to install hard standing for a permanent power supply to an existing lighting column on the Blackgrove Road roundabout.

While we carry out this work, there will be a lane closure in place Blackgrove Road managed by traffic lights.

When will these works take place

There will be **2-way daytime traffic lights** set up from **8.30am to 5.30pm**, weekdays only (Monday to Friday) from Monday 16 June to Friday 4 July. **At weekends, the traffic lights will be removed.**

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates

Duration of works

Three weeks general verge works from Monday 16 June to Friday 4 July. **Weekdays only**, Monday to Friday.

No weekend working.

Set up temporary day time 2-way traffic management from 8.30am to 5.30pm, Monday to Friday.

Increased travel times.

Minimise disruption as much as possible for the community.

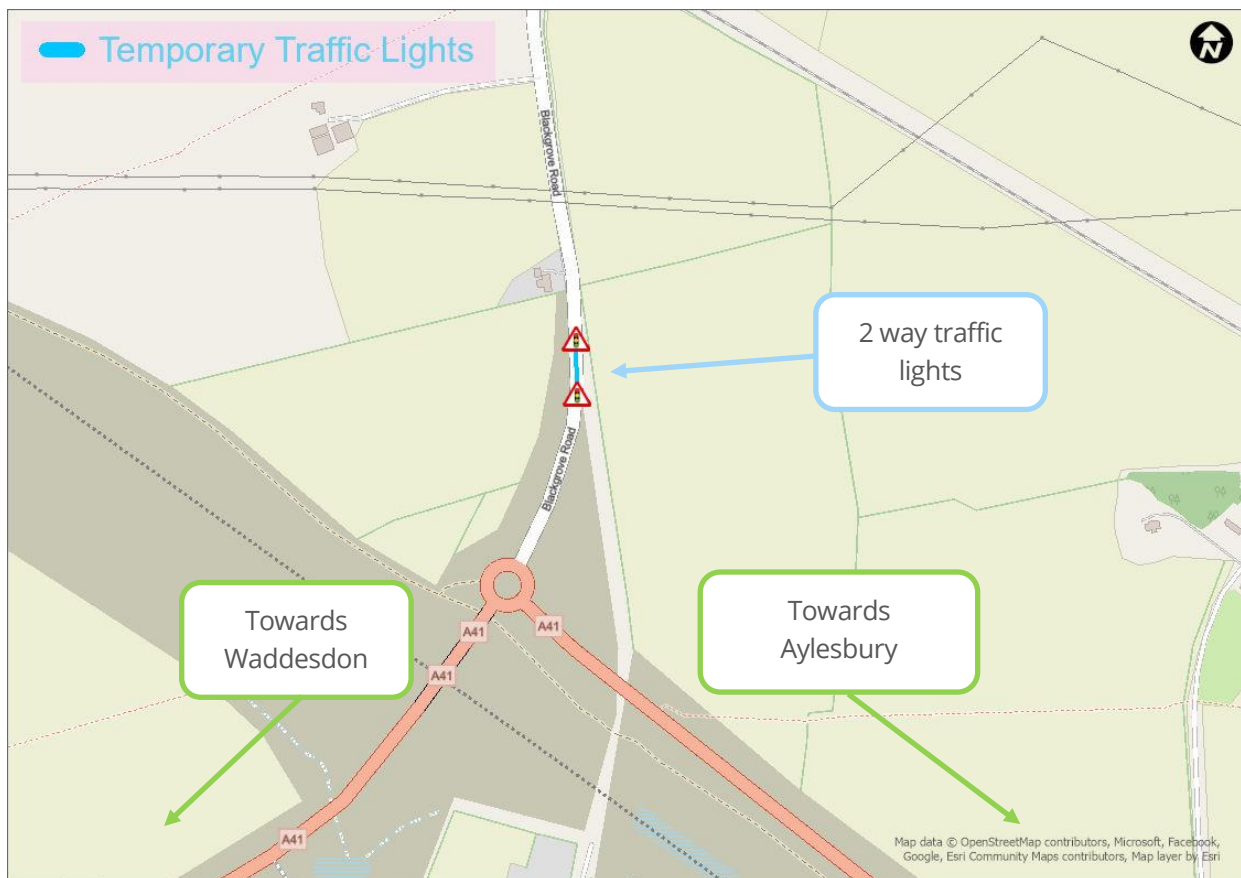
