# **Borehole survey on Fellows Road, Swiss Cottage area**

High Speed Two (HS2) is the new high speed railway for Britain.

## What are we doing

On **Monday 2 June 2025** we will be carrying out a borehole survey on Fellows Road between the junction of King's College Road and Briary Close. We will be lifting the manhole cover to take some measurements and photographs of the borehole beneath.

## How might this affect you

We will need to suspend up to two parking bays on either side of the borehole, please refer to the map below. **This work will be for an hour between 8am to 6pm**. This work will not be noisy. We will open the parking bays once we have completed the surveys
