#### What are we doing?

SGN will be doing some work on Church Lane, near the junction of Featherbed Lane. They need to close a part of the road in order to inspect and measure the gas mains, getting them ready for new connections.

There will also be a short section of single lane traffic managed by two way lights. The road will remain in operation throughout the duration of the works without the need to carry out any road closure.

#### When will these works take place?

Traffic lights and lane closure will be in place on this road from 19 May to 30 May 2025, 24 hours a day.
