# Notice of road closure, Radstone Road, Radstone

High Speed Two (HS2) is the new high speed railway for Britain. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

#### What are we doing?

In June National Grid (NGED) subcontractor KIS, will be carrying out utility works along Radstone Road. A road closure will be needed to install a new NGED cable alongside the verge of the existing road. As these activities are within our works area, we will be providing traffic management to accommodate the road closure.

Due to safety reasons and the narrow width of the road, these works will require a full road closure. We will reopen the road as soon as possible.

#### When will these works take place?

A section of Radstone Road will be closed, with signed diversion in place, on the following dates:

Monday 9 June to Sunday 6 July 2025

These works may be subject to change due to circumstances outside of our control. We will update communities in advance.
