

Notice of tower crane installation at Old Oak Common station

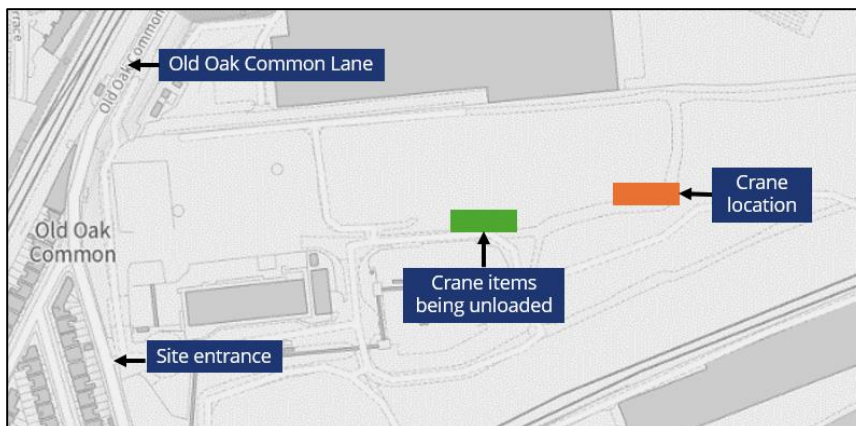
High Speed Two (HS2) is the new high speed railway for Britain. BBVS is the contractor working on behalf HS2 to construct the Old Oak Common station.

Tower crane installation

On Monday 12 May for approximately two weeks, we will be assembling the second Heavy Lift tower crane. This tower crane will be put together using the Heavy Lift tower crane that was previously installed on site a couple of months ago.

For this to happen a number of deliveries will be received onsite from approximately 6am. We have contingency dates for Saturday 17 – Sunday 18 May and Monday 26 May if works are delayed due to bad weather.

Operatives installing the crane will use hand signals to communicate and the only sound should be the crane's engine as it goes up. This is not expected to cause a disruption to the local community.
