High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To ensure the local road network has capacity when the future HS2 Interchange station is operational, we have been improving and expanding the existing road network. Located near to the NEC and Birmingham Airport, the Interchange Station will be a major transport gateway for the region. A new roundabout has been constructed linking the Interchange station to the A452 and A446. As our work on this junction nears completion, we need demolish the former A452 Overbridge in summer 2025. To prepare for the demolition of the bridge we first need to complete trial holes and install barriers.

To safely carry out our works we will install the following temporary overnight closures:

A452 Chester Road northbound

Each night between Monday 9 June to Friday 13 June 2025 from 10pm and 6am.

A446 Stonebridge Road southbound

We will close the southbound carriageway slightly earlier each night between Monday 9 June to Friday 13 June 2025 from 9pm and 6am.

Following these works we will require further closures to safely prepare and complete the bridge demolition. We will share a further communication on these works once they have been confirmed.

Please note that these works are subject to consent.

Access to Packington Lane/Park Farm

Traffic wishing to access Packington Lane/Park Farm via the A452 Chester Road northbound during these closures may need to allow more time for journeys.


A452 Chester Road northbound diversion


A446 Stonebridge Road southbound diversion
