What are we doing?

We need to complete the tie-in of the new temporary link road onto the existing carriageway, including the excavation of trial holes for utilities works. To regulate the traffic flow, we require traffic management while these works are taking place.

When will these works take place?

The temporary traffic lights will be in place between:

• 30 June extended until 11 August 2025 from 8.30am to 5.30pm.

These dates may be subject to change due to circumstances outside of our control, such as weather and ground conditions.

We will endeavour to complete these works in or around the set time frames. Please check the HS2 website regularly for any changes or updates.

Manage any environmental impacts, such as traffic and noise.


Respond promptly to any complaints and take appropriate action.
