



# Notice of road closure on B4114 Birmingham Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

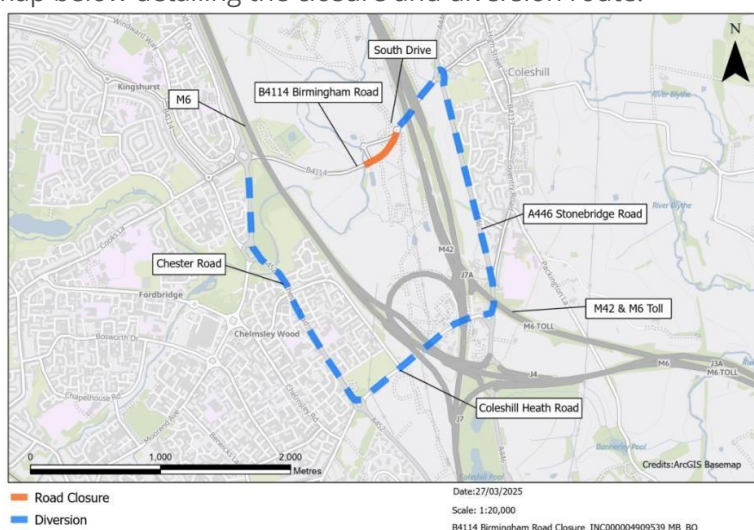
As part of the ongoing preparations for the HS2 railway construction, we will be carrying out essential construction works to construct the viaducts spanning the B4114 Birmingham Road. These works will include the placement of viaduct segments that will form part of the new HS2 railway structure. To facilitate these activities, a full road closure will be in place on the B4114 Birmingham Road, from the junction of Manor Drive to the River Cole bridge.

## When the work will take place

To complete the works safely, we will install a full road closure along the B4114 Birmingham Road. The works will take place from 7am on Monday 14 July to 7am on Monday 11 August 2025. The road closure will be in place 24/7. All vehicles will be directed to use the diversion in place. Pedestrian and cycle access will be maintained.

## Duration of works

Road closure of B4114 Birmingham Road from 7am Monday 14 July to 7am Monday 11 August 2025.

The closure will be in place 24/7.
