

# Notice for the temporary closure of Cromwell Lane, Burton Green

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

We are building the 700 metre Burton Green Tunnel that will transport HS2 trains through Burton Green. The green tunnel will have enhanced environmental features such as extensive tree planting, new footpaths, and better connections to local woods - helping it blend into the natural landscape.

## The work we will be doing

As enable the permanent realignment of Cromwell Lane, we first need to carry out multiple utility diversion works. To do this safely, we will require phased closures in 2025 and 2026.

## When these works will take place

The first closure of Cromwell Lane will be from **Monday 28 July to Saturday 23 August 2025**. Please note that the closure will be in place **24 hours a day** while the works are carried out. We will require a second closure in the autumn to carry the next stage of works. Details of this closure, and 2026 closure dates, will be shared once the dates are confirmed.

## What to expect

You will notice increased levels of construction activity and some disruption to your travel times. Access to properties will be maintained, with cyclist and pedestrian access available throughout the work. A fully signposted diversion will be in place during the closure. Please see the map on page two.

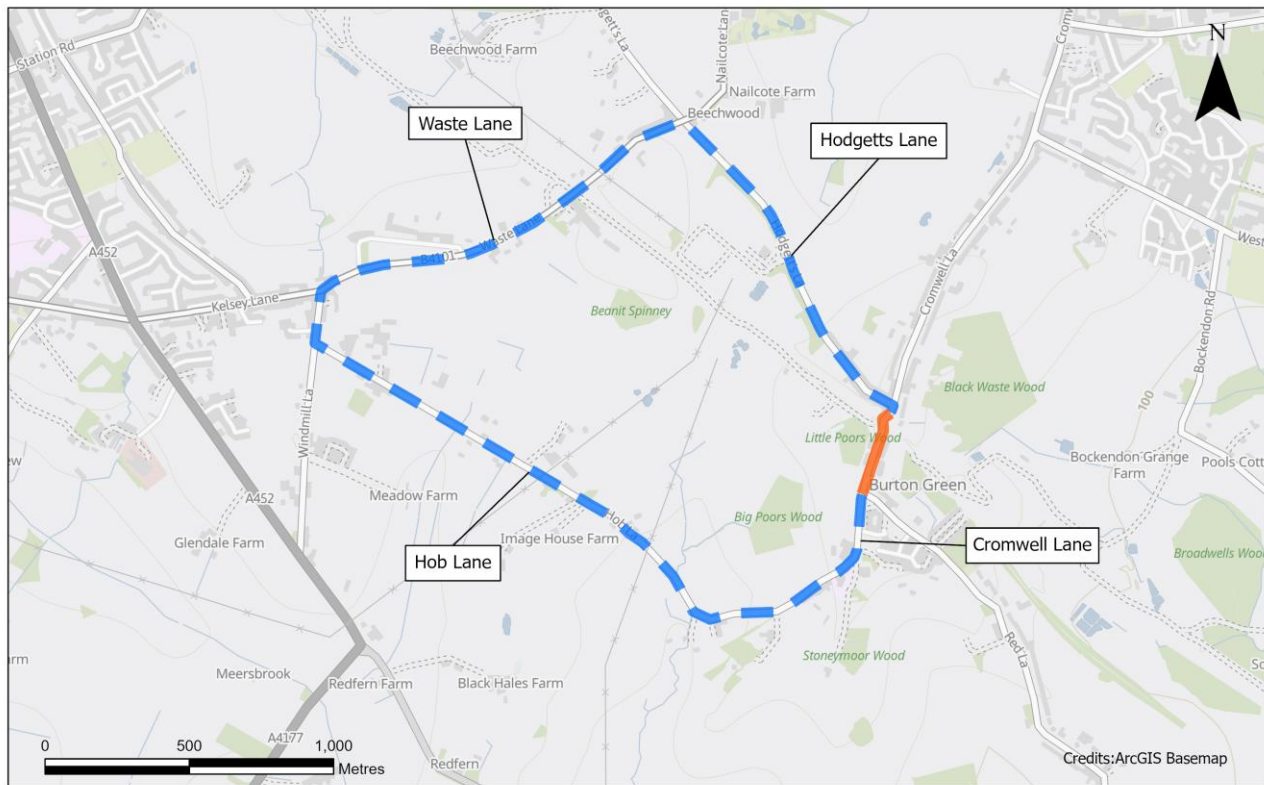

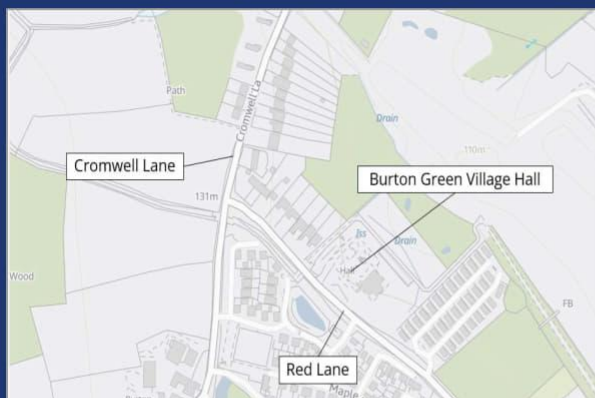
