Update: borehole in West Ruislip Station car park

High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

We wrote to you in June 2025 about works to drill a borehole in West Ruislip Station carpark from 25 June to 3 July 2025. These works are now expected to take place from **20 July to 25 July 2025**.

We will carry out a visual survey using handheld equipment. We will then drill a borehole in the ground. Once the borehole is complete, we will install a secure cover. The borehole will be located in between parking spaces so we can routinely access it to take readings.

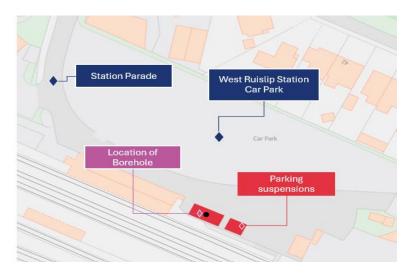
The location of the work is shown on the map below.

How this may affect you

During this work, we will suspend seven parking bays in the West Ruislip Station car park. You may notice some noise from drilling. We will use noise reducing barriers where possible.

You may see staff return at intervals to carry out monitoring.
