



# Notice of overnight closures on A5 Hints Bypass

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## Maintenance on the A5 Hints Bypass works area

We are working to construct the A5 Hints bypass Overbridge that will allow HS2 to pass under the A5. To continue the safe running of this roadworks scheme, we will need to undertake maintenance works of the CCTV cameras along this bypass.

These works will require us to close the A5 in both directions between Mile Oak and Weeford Junction to allow the maintenance of the cameras to take place. A sign posted diversion will be in place.

## When will the work take place

The overnight closures on the A5 Hints Bypass, in both directions will be between 9pm and 5am on **7 July, 11 August** and **15 September 2025**.

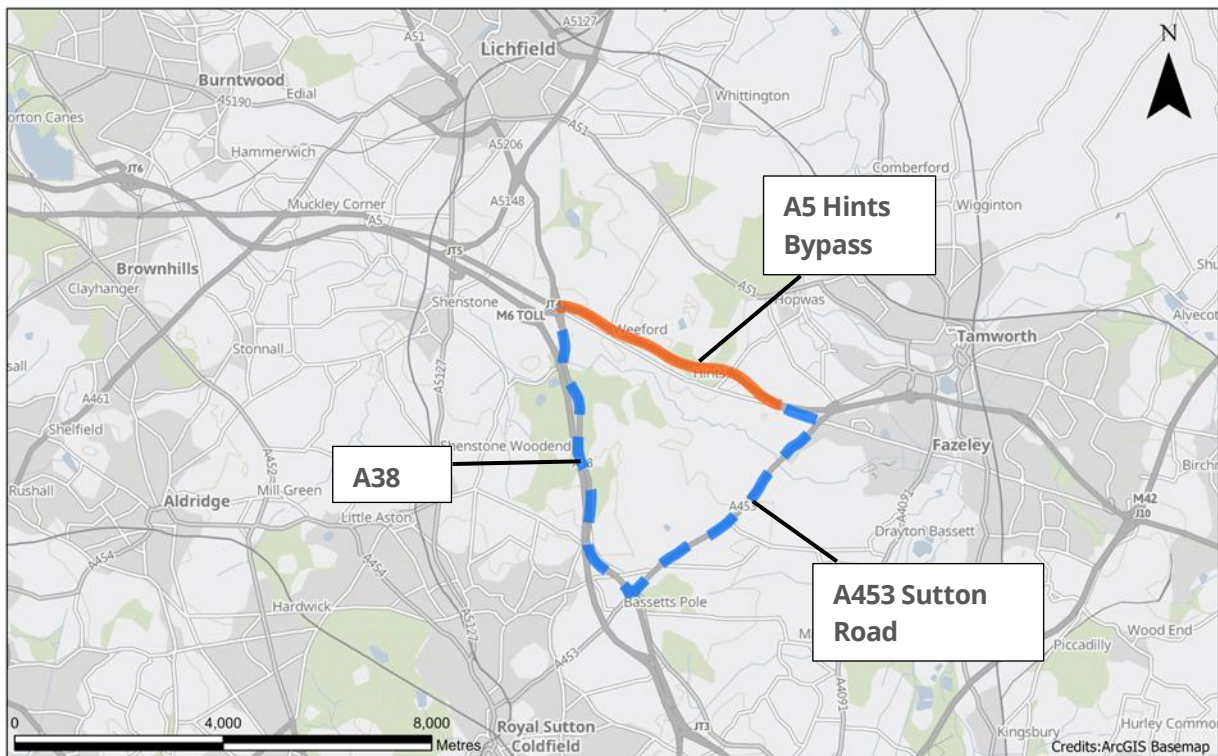
