Update: Borehole work on Fellows Road, Swiss Cottage

High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing


We wrote to you recently about works to fill in a borehole on Fellows Road on the 9 and 10 October 2025. Due to unforeseen circumstances these works did not take place and have been rescheduled for **Tuesday 18 November 2025** and finish on **Wednesday 19 November 2025**. During these works we will fill a borehole in the road outside 113 Fellows Road with concrete. We will place barriers around the borehole while we work. The barriers may stay in place until **20 November 2025** to allow the concrete and tarmac to set.

How this may affect you

We will suspend two parking bays around the borehole. There may be some noise when we dig a small section of road and fill the borehole with concrete.

We apologise for any disruption this work this may cause.
