



# Notice of New Manor Drive Realignment

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

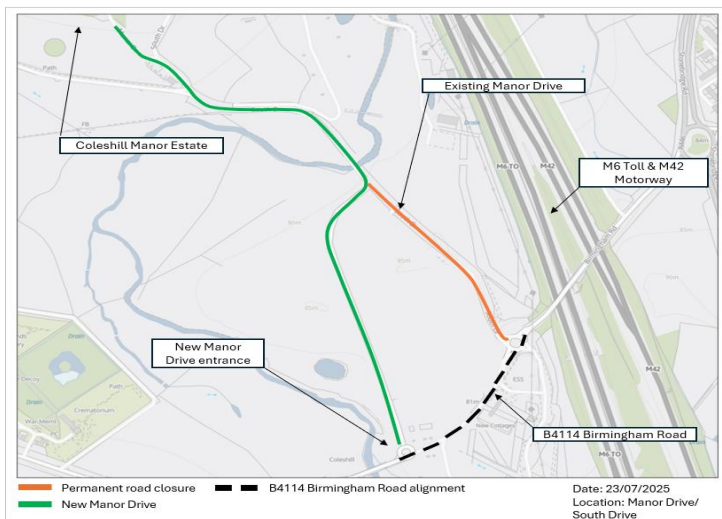
As part of our continued preparations for the construction of the HS2 railway, we have been working to build a new alignment of Manor Drive to provide access to the Coleshill Manor Estate. The new road will be accessed via the new roundabout on the B4114 Birmingham Road and will reconnect with the existing alignment at the River Cole crossing. From the date specified below, all road users will permanently switch to this new route.

## When the work will take place

In the early hours of Monday 11 August, the newly realigned Manor Drive will officially open to road users, and the existing route will be permanently closed.
