To continue our preparation of the construction of the HS2 railway, we will be undertaking emergency repair works on the M6 Toll Road to fix a manhole cover. To complete these works safely, overnight lane closures of 1 and 2 will be installed for the duration of the works.

Overnight lane closures of 1 and 2 will be in place on the M6 toll southbound from 8pm on Saturday 26 July to 8am on Sunday 27 July.
