High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

In August 2025, we'll launch the Lawley Middleway Bridge a key part of the route that will carry High Speed trains over Lawley Middleway and into Curzon Street Station, right in the centre of Birmingham.

The majority of our work has been conducted off-line. However, to further minimise our impact on road users, we will only be working at night and during the school holidays when the road network is typically quieter.

When will this work take place

To ensure the safety of all road users, Lawley Middleway will be closed nightly from Garrison Circus to Curzon Circus between **10:00 PM** and **6:00 AM**, starting from **15 August** until **24 August**.

If you need to travel during these hours, please plan ahead. A clearly signed diversion route will be in place for all road users.

- Pedestrians and cyclists will be provided with a safe, signed diversion route.
- Access for emergency services will be maintained at all times, with safe escort through the closure in case of an emergency.
- Vehicle access to nearby identified critical businesses will also be maintained throughout the works.

Please refer to the map overleaf for details of the diversion route.

We appreciate your patience and cooperation as we carry out these essential works.

Future work

Please note that further overnight closures are being planned from **3 October to 18 October**. These will be required to complete finishing and remedial works, as well as to remove the substructure that supported the bridge during its launch. We expect the diversion and access arrangements to be the same.

Duration of works

Between 10:00 PM and 6:00 AM, starting from 15 August until 24 August.

What to expect

A fully signed diversion
- allow 20-30 minutes.

This work will be heard
- noise levels will be monitored

Keep noise and disruption to a minimum

Keep all sites safe and secure.

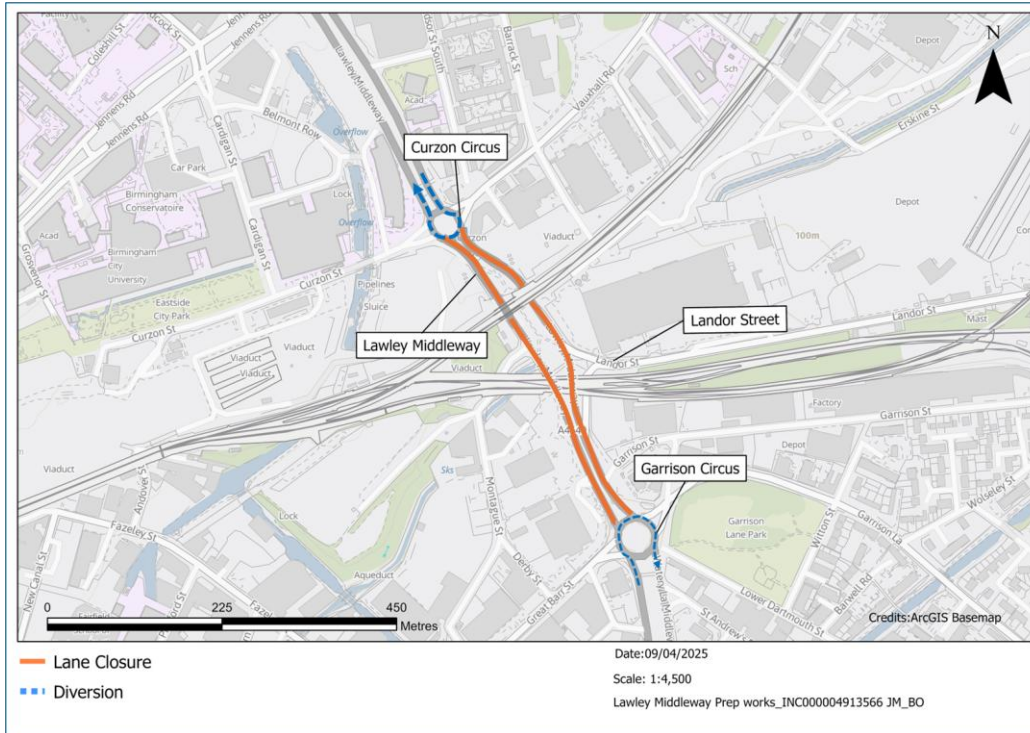

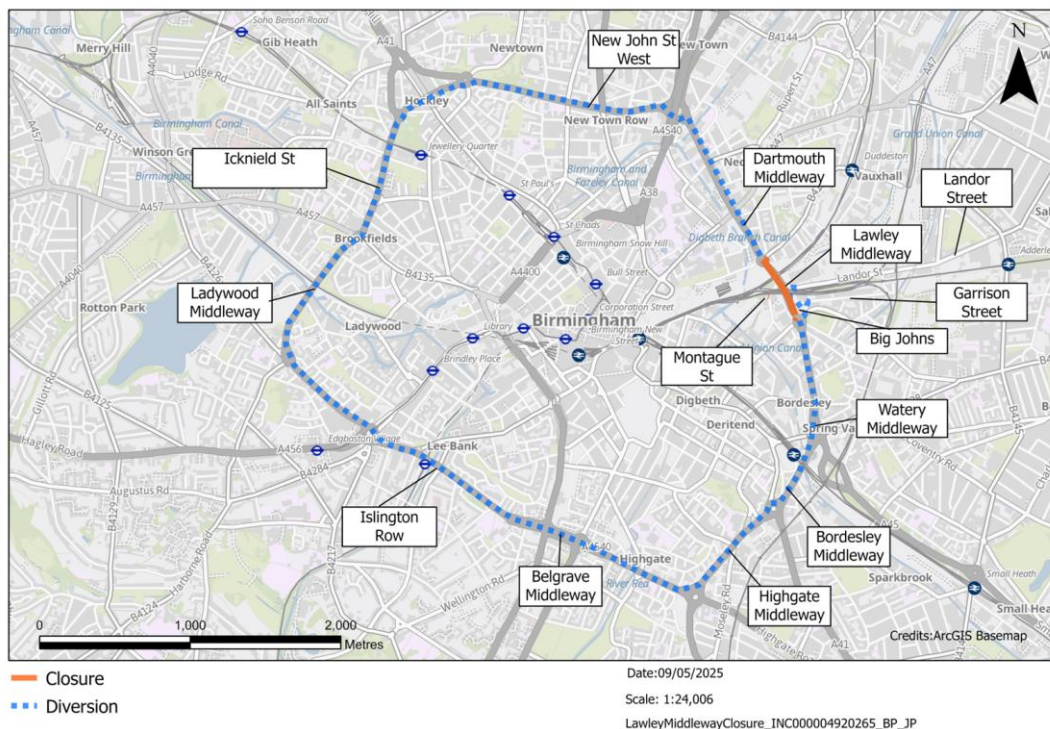

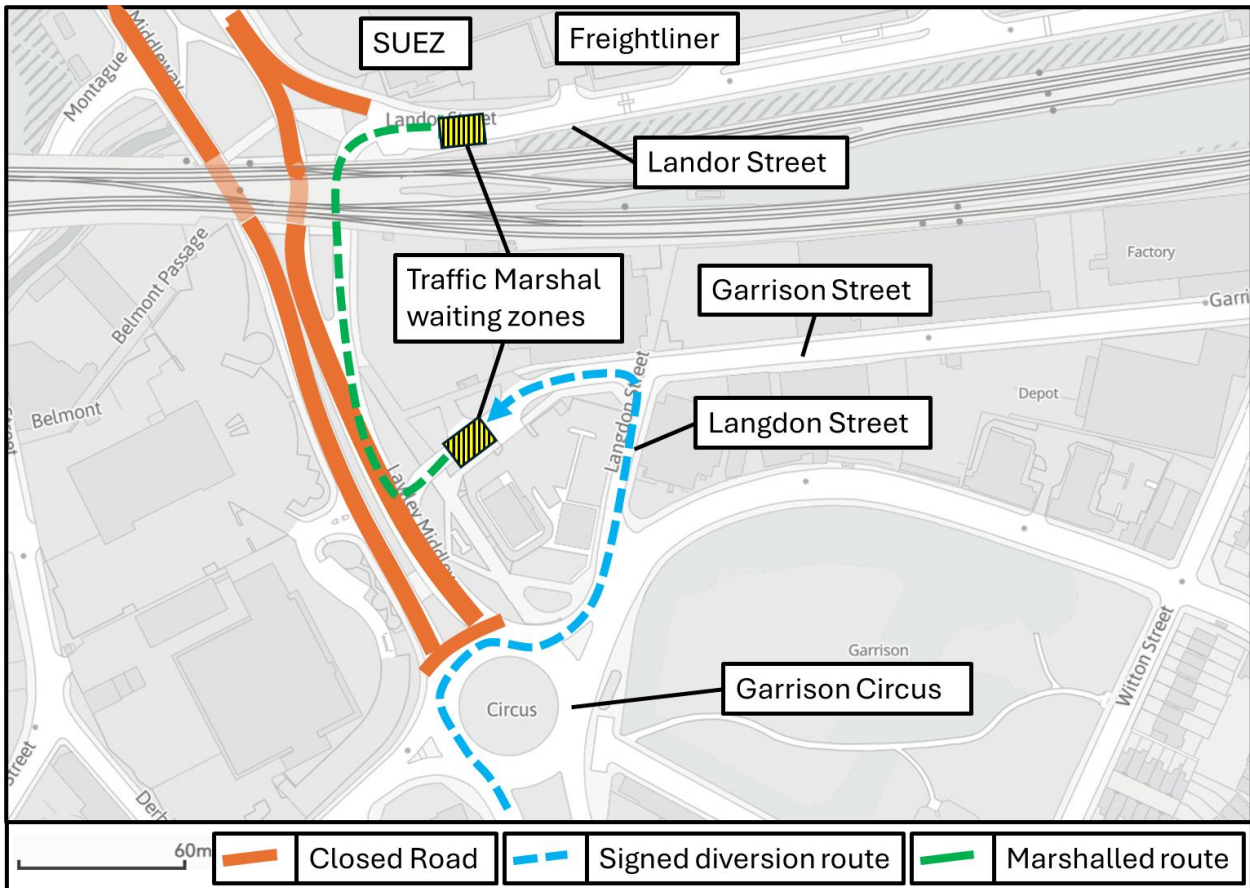

Access arrangements for critical businesses on Landor Street

Between **10pm** and **6am**, vehicles will be diverted (fully signed) onto Langdon Street, where they'll be met by one of our traffic marshals. The marshals will then escort vehicles northbound using the southbound carriageway onto Landor Street.

We'll also have marshals assisting vehicles leaving Landor Street, to ensure everyone remains safe throughout the closure.
