Update: Overnight vegetation trimming for Adelaide Road site

High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

From **9pm Saturday 30 August 2025 to 12pm Sunday 31 August 2025** we will be carrying out vegetation trimming along a section of Network Rail land surrounding our Adelaide Road Ventilation Shaft and Headhouse site.

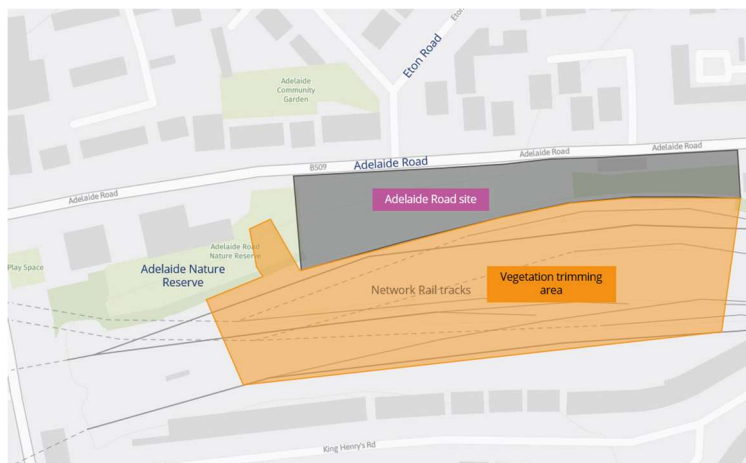
We must complete this work to ensure clear visibility for our monitoring equipment located in the area. The works will take place overnight to avoid rail disruptions.

How this may affect you

Trimmers and hand tools will be used for this work. We are not expecting to cause any major disruption to local residents; however, you may hear additional noise at times.

We will aim to minimise disruption where possible, we apologise for any inconvenience these works may cause.
