Community engagement at a glance (March - May 2025)

Since we last met...

We have engaged with approx. 300 people at engagement meetings.

We have had 1,852 visitors to the HS2 in Camden website with 1,356 subscribers to news updates.

From the start of the project, a total of £1.994m has been awarded to 31 local projects in Camden through CEF and BLEF.

Engagement Events

ADELAIDE ROAD

Update on pause to works at Adelaide Road site

- Works at the Adelaide Road Ventilation Shaft and Headhouse site were brought to a safe stop in May 2024.
- The hoarding will remain in place, and there will be 24-hour security. No site activities will take place other than monitoring, design and maintenance works at times.
- Welfare facilities at our Adelaide Road site may be used during certain periods, however we will notify the local community in advance of this.



- Monthly virtual 1:1 drop-in sessions for future tunnelling works (twin-bore Euston Tunnel and twin-bore Northolt Tunnel East) were scheduled through March 2025 to May 2025 with three people attending. The residents were interested in the current works on Adelaide Road and Camden in general, distance of tunnelling works from the residential buildings, as well as the future Old Oak Common Station and development of the area.
- Monthly virtual 1:1 drop-in sessions for Adelaide Road Vent Shaft (ARVS) site were scheduled through March to May 2025 with two residents attending with questions about the pause to works at the Adelaide Road Vent Shaft site, dust concerns, and property questions. Additionally, they raised questions about traffic management in the area due to the planned utility works taking place in the South Hampstead area.
- South Hampstead utility works drop-in in-person update and information event at Swiss Cottage Community Centre held on Tuesday 27 May 2025. Twenty people attended the event. Concerns were raised about traffic impacts and street parking for businesses. There were questions about traffic access through College Crescent during phases one and six of the utility works and concerns from residents outside the work area about impacts on traffic in their areas.. Questions around the tunnelling programme were also raised.
- Door knocks also took place in the South Hampstead area to engage with stakeholders and community members ahead of the planned utility works starting from July 2025.

EUSTON APPROACHES AND CAMDEN CUTTING

Regular engagement events have been held in the Euston Approaches to update on current and future works:

- Asset protection engagement: meetings, site visits and correspondence with the residents and businesses along Park Village East, Parkway and Mornington Terrace including Park Village Studios, Edinboro Castle, York & Albany, Goldsmith House, Nash House.
- 14 advanced notifications have been issued including the notice of works during the Easter period, weekend and overnight works in the Euston Throat, utility diversion works on Hampstead Road, power cable pulling works through Lidlington Place, Granby Terrace bridge and Stanhope Street, ongoing surveys and trial holes in various locations on Parkway and Hampstead Road.
- Weekly updates on coordinated map of utility and other works in Euston and Euston Approaches area. <u>Utility works in Euston and Euston Approaches area - HS2</u>
- Meetings held with local organisations regarding community investment opportunities including MIND, Little Village, Global Generation, Camden Highline as well as London Zoo, Surma Community Centre and Regent's Park Children's Centre.

EUSTON STATION

Recognising the Government's review of Euston Station design, HS2 construction partner MDjv is continuing with essential preparatory work to facilitate the delivery of the future station. In April, we completed the construction and handover of the new community hub at the old Maria Fidelis school on North Gower Street. Local organisations have begun to deliver community initiatives from there.

Drummond Street Traders

- A project report was issued for late February and April with bi-monthly forums taking place in March and May 2025. The focus during this period has been upcoming Drummond Street gas works, including Virgin Media enabling works.
- o In-person business visits continued with 1-2-1 engagements with 20 businesses on Drummond Street with a focus on upcoming works, traffic management, signage and looking at ways to reduce impact to business operation.
- The engagement team continues to work with the Drummond Street forum to improve signage and wayfinding.

Stephenson Way group

- In late February a risk register workshop took place, the purpose was to review risks associated with construction activities, identify if these were live or determine collectively if some could be closed. The next workshop is planned for late 2025.
- Bi-monthly forums took place in March and May and a project report was issued for April 2025. The focus during this period has been remaining activities required to begin power migration from the existing Traction Substation (TSS) into the new structure, UKPN ducting works on Stephenson Way and on-going gas diversion in the area (highways and behind the hoarding).

Ongoing monthly engagement - MDjv is continuing regular meetings with: The Wesley Hotel, Royal College of General Practitioners (RCGP), University College London (UCL), Exmouth Arms, Friend's House, The Margarete Centre (108 Hampstead Road), IQ Bloomsbury, The Office Group, The Welcome Trust and One Eversholt Street. The focus during this period has been asset protection and on-going works.

WORKS UPDATE

Community Hub (Maria Fidelis Old School)

- o A new Euston Community Hub opened in spring 2025 for the local community.
- The hub is a vibrant and dynamic space for local charities and organisations to deliver a range of community activities. Since opening, local organisations have begun delivering community initiatives from there.

Traction Substation

- Work is progressing at the site; in May 2025 we decommissioned the acoustic shed, which
 was built to allow us to contain construction noise from the new Traction Substation (TSS).
- o During summer 2025 inspections to the new structure will continue. This will enable power migration from the existing TSS to the new one, which will begin from autumn 2025.
- o Following the acceptance of the power migration we expect that the new TSS will come into operation in 2026.





Update on utility works in the area (highways and behind the hoarding)

- We have continued to progress with utility works in the area, including removing the redundant substation and constructing manholes on Cardington Street (junction of Hampstead Road). The manholes will enable the sewer diversions. At the same time, we completed the main gas diversion within the site and decommissioned the old watermain on Varndell Street and Cumberland Market.
- Upcoming and ongoing work include work within the worksite and neighboring streets, such as Euston Street, North Gower and Drummond Street gas main diversion works; Eversholt Street gas works; UKPN works on Euston Street, Cobourg Street South and Stephenson Way.
- To facilitate these works, pedestrian footpaths will be altered and redirected. There will be instances where we temporarily close roads and reduce roads to one lane (Drummond Street, Euston Street, North Gower Street and Eversholt Street).

Coordinated communication of utility works in the Euston wide area

- While options for the delivery of Euston are explored, HS2 Ltd continues to complete enabling works across the HS2 site to prepare for a future station and HS2 terminus.
- This includes some utility works around Euston Station, and on Hampstead Road and Regents Park Estate delivered by HS2 construction partners – Skanska, Costain, Strabag (SCSJV) and Mace Dragados (MDJV) joint ventures involving where necessary utility companies responsible for power, water, gas and other connection supplies.
- All works are co-ordinated between contractors with the aim of to reducing the impact on residents and maintaining access for the general public at all times. To ensure clear communication of works the 'Utility works in Euston and Euston Approaches' area web page has been created and includes the following information:

This summer MDjv will be installing bleed kits around Euston Station site. This will be easily accessible for the residents and businesses if required in an emergency. They will be located at gates (inside) but can be released in emergency there will be signage outside the gate.

HS2 Community & Environment Fund (CEF) and Business & Local Economy Fund (BLEF) supported projects

- To date £1.994m has been awarded to 31 local projects benefiting Camden through CEF and BLEF. For details of CEF and BLEF funding follow the link to online interactive map <u>HS2</u> <u>Community and Business Funds project map – HS2 Community and Business Funds</u> (<u>hs2funds.org.uk</u>)
- This includes 18 CEF awards totalling £1.21m, 1 BLEF award of £651k and 12 Euston Meanwhile Use (EMU) awards totalling £133k.

- To date, the programme has invested £19.1m and supported 349 projects along the line of route.

Honest Grind Coffee receives HS2 CEF funding

Honest Grind Coffee is a social enterprise and specialty coffee roastery based in Camden, London, funded by Camden Council's Integrated Youth Support Service. Its mission is to support vulnerable young people by providing bespoke employability training and paid work opportunities. Participants gain hands-on experience in the coffee industry by roasting, packaging, and sales, equipping them with industry-standard skills and clear pathways into long-term employment.

£100,000 of CEF funding was awarded to Honest Grind Coffee to support the organisation for a further three years and enable them to work with an additional 150 local 16-18yr olds helping them make better decisions, feel positive about themselves and find their way to legitimate economic independence.

Working groups

Noise Insulation Working Group (NIWG)

The last meeting was held on Wednesday 26 March 2025.

Traffic Working Group (TWG)

- Bi-monthly online meeting held on 7 April and 2 June 2025.
- Key points at the meetings:
 - Update from MDJV, SCSjv, UK Power Networks on ongoing and upcoming works in the Euston and Euston Approaches area;
 - Utility works on Finchley Road, South Hampstead area;
 - Update on gas main works on Drummond Street; and
 - Safety concerns around Eversholt Street, walkabout was offered to review the area, this yet to be organised.

Air Quality, Trees, and Open Spaces Working Group

The group met on 15 May 2025.


Key points at the meetings:

- Update on Air Quality monitoring in the area. It was noted that emissions standards compliance had been 100% for the first quarter of the year.

- o It was agreed that LB Camden would be asked to provide details of how it manages the cumulative impact of major developments in the area. This would allow the group to assess if further measures might be requested from LB Camden, HS2, The Euston Partnership or Euston Development Company/Corporation once established.
- It was agreed that LB Camden and MDjv would be asked to explore an indoor clean air advice advisory initiative following the success of indoor monitoring and advice carried out by LB Camden.


Complaints and Enquiries

o In total 10 complaints and 236 enquiries were received by the HS2 Helpdesk between February and April 2025. May data will be covered in the next report.







