Update: Vegetation trimming for Adelaide Road site

High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

For one day every second month until the end of October 2025 we will be carrying out vegetation trimming surrounding our Adelaide Road site. No trees will be removed, only low-level vegetation.

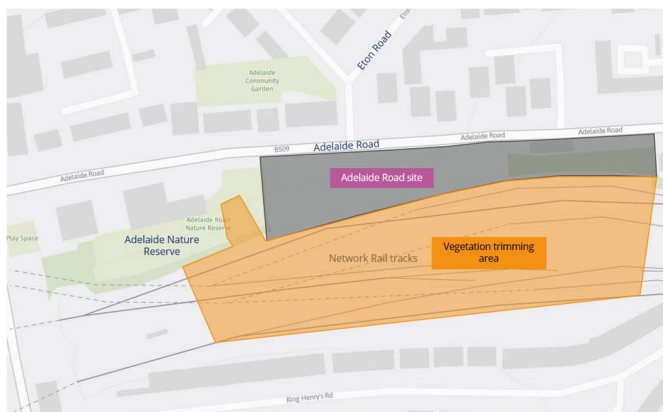
This work is needed to ensure clear visibility when taking readings from the monitoring equipment placed in various locations.

These works will take place during core working hours. Night works may be required in the Network Rail land (near the train tracks) to avoid rail disruptions during some months. We will provide updates at HS2inCamden.co.uk in advance of this.

How this may affect you

Trimmers and hand tools will be used for this work and are not expected to cause any major disruption to local residents; however, you may hear additional noise at times.

We will aim to minimise disruption where possible, we apologise for any inconvenience these works may cause. The map below shows the location of the Adelaide Road site and vegetation trimming works.

Duration of works

One day every second month until the end of October 2025 during core working hours

Night works may be required some months between 10pm and 6am

Core working hours

Monday to Friday – 8am to 6pm

Saturday – 8am to 1pm

We may be on site for an hour at the start and/or at the end of each shift

What to expect

You may notice HS2 workers and some noise from trimmers and hand tools being used

What we will do

Brief contractors to be mindful of neighbours and continue to monitor working methods to reduce disruption
