# Lane closure on Stanhope Street corner with Park Village East – 4 August to mid-September 2025


We need to install UK Power Network (UKPN) ducts in the road and footpath outside our site access gate at the junction of Stanhope Street and Park Village East, opposite Cubitt Court.

We will begin works on Monday **4 August** and expect to complete these by mid-September. We will set up the site area from **10pm** on Sunday **3 August** to begin works the following day.

We will also be working on the weekend of **9 and 10 August** from 8am to 5pm on Saturday, and 10am to 4pm on Sunday. To reduce impacts to residents, there will be no breaking concrete after 1pm on Saturday and no noisy works on Sunday.

To complete these works, we will install a 2-way set of temporary traffic lights to control the flow of traffic. There will be crossing points at either end of the worksite to divert pedestrians to the opposite footpath.

We will minimise noise impacts where practicable to ensure we are working within the approved limits.
