What are we doing?

Stoke Mandeville Relief Road connection – from mid August to early September, we will be closing a section of the A4010 Risborough Road in order to build the connection with the new relief road, which has been under construction throughout this year.

The new relief road will remain closed to public traffic to allow Thames Water to complete utility works along the new road. Traffic will remain on the existing A4010 Risborough Road at the conclusion of this road closure from early September.

Pedestrian access will be maintained throughout the closure and a signposted diversion route for general traffic will be in place. In order to complete the required work and reopen the road as swiftly as possible, we will be working 24 hours a day with consent from Buckinghamshire Council during these periods.

We expect a further road closure of the A4010 Risborough Road later in the autumn once these utility works are complete. We will publish further details on this when they are confirmed. After this, the new relief road will open to the public in conjunction with phase 2 of Buckinghamshire Council's South East Aylesbury Link Road (SEALR).

When will these works take place?

The A4010 Risborough Road will be closed between:

• 7am on Wednesday 20 August to 4am on Monday 8 September

We will endeavour to complete these works in the period stated above. However, these dates may change due to conditions outside of our control. Please visit **www.HS2inyourarea.co.uk** where the latest updates on these works will be published.

Access for residents and businesses along the A4010 Risborough Road, including Fremantle Court, Harvest Petrol Station and The Bucks Goat Centre, will be maintained via the signed diversions route. We have been advised that all of these businesses will be open as usual.
