## What are we doing?

In 2024, we temporarily realigned Ellesborough Road and Bacombe Lane to enable the construction of the Wendover Green Tunnel.

In August 2025, we will be undertaking some topographical surveys in this area. The surveying will require temporary traffic management for a few hours. The traffic management will be during off-peak hours to minimise disruption.

## When will these works take place?

Please note, these dates may be subject to change due to circumstances outside of our control but will be completed on or around the timings specified.

Should our team finish earlier than planned, we will lift the traffic management when practicable.

Manage any noise or traffic impacts.

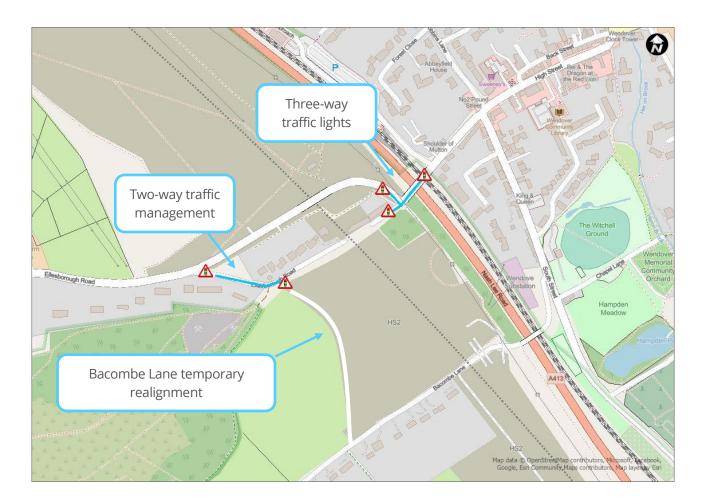
Access available for residents and pedestrians.
