What are we doing?

As part of the Shipton Lee Road realignment, a section of the road was closed to construct the new road realignment over the new Edgcott overbridge. The existing bridge on Shipton Lee Road will be demolished to accommodate the earthworks to construct the HS2 railway. The road will re-open on the new alignment at the end of April 2026.

The new end date for these works reflects a technical change which means additional works must be undertaken to the structure.

Residents impacted by the closure will be contacted directly to arrange access requirements.

Access from Shipton Lee Road to the Berks Bucks and Oxfordshire Wildlife Trust (BBOWT) reserve of Finemere Wood will be maintained throughout the closure from the east, Quainton.

To carry out these works safely and effectively we will need to put in place a road closure with signed diversions. Our teams will be working in open trenches on and around carriageway.

When will these works take place?

A section of Shipton Lee Road will be closed from 21 July 2025 until 30 April 2026.

These dates may be subject to change due to circumstances outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes or updates.

Respond promptly to any complaints and take appropriate action.

Provide a full diversion route for road users.

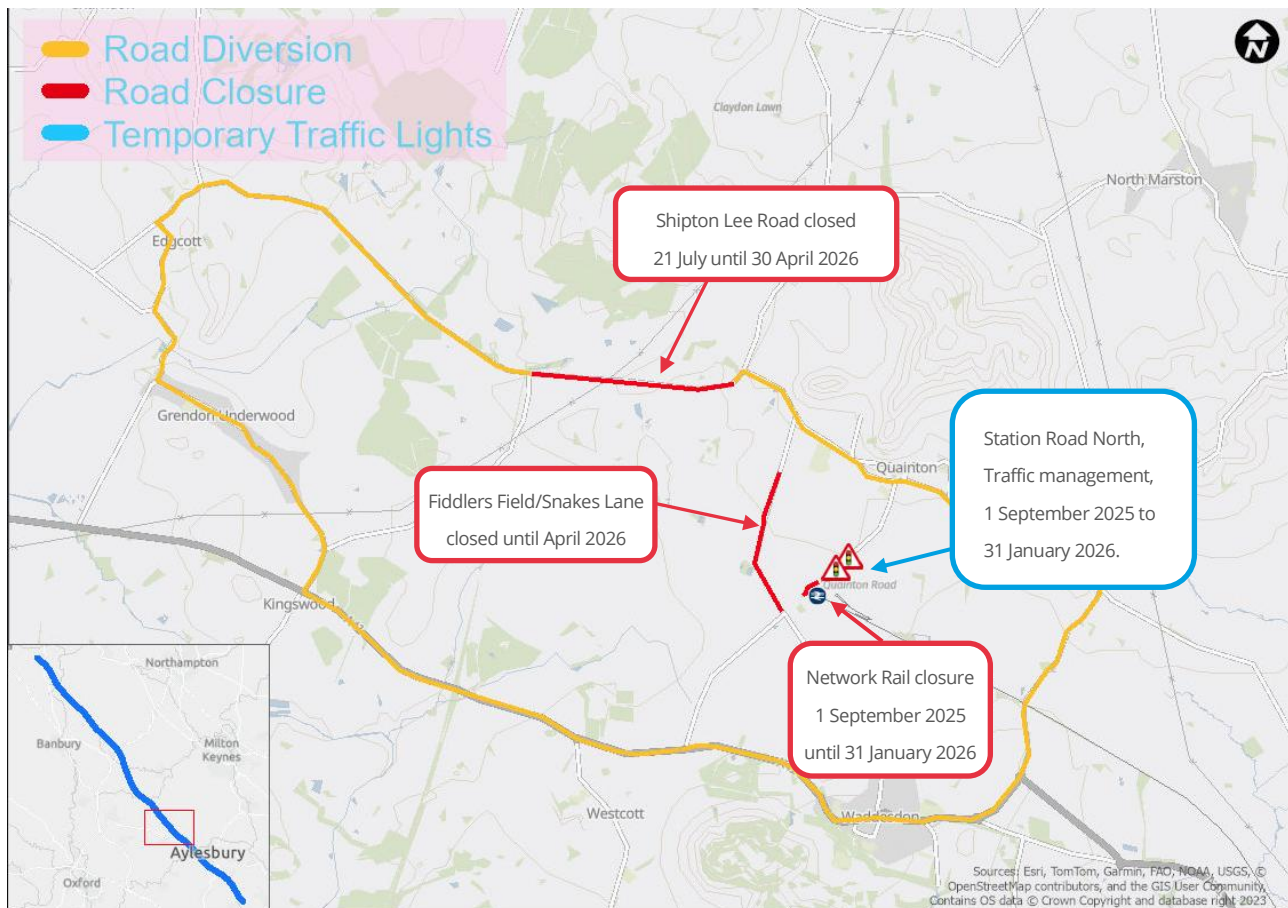

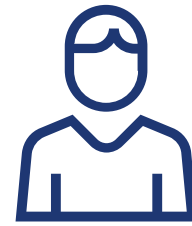
Where will the works take place?
