



Update notice of overnight closure of A452 Kenilworth Road southbound carriageway – Meriden

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We previously advised you that we will be closing the A452 Kenilworth Road southbound carriageway Meriden **overnight on Saturday 9 August 2025**. Due to circumstances beyond our control, we will now be closing the A452 Kenilworth Road southbound carriageway Meriden **overnight on Saturday 23 August 2025**.

This will allow us to make some modifications to the current traffic management layout on the southbound carriageway of the A452 Kenilworth Road between Meriden roundabout and Bradnocks Marsh roundabout.

Update: When will these works be taking place?

To carry out these works safely we will be closing the southbound carriageway overnight on **Saturday 23 August 2025** from **8pm to 6am**.

Please note that if the works are completed early, we will reopen the carriageway earlier than 6am.

Access to residents and business will be maintained throughout the closure and a fully signed diversion will be in operation. Please follow the diversion signs.

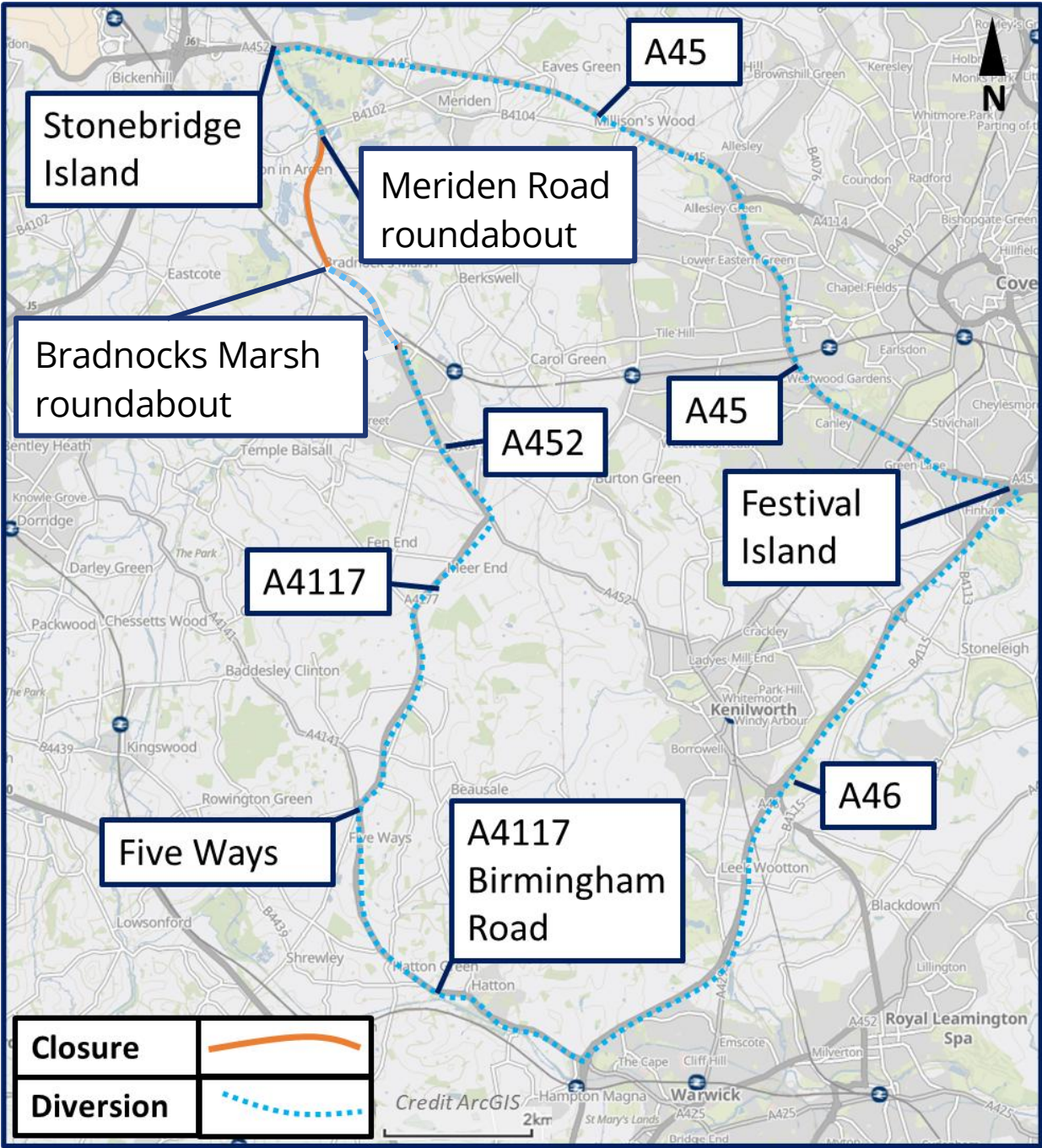
The diversion route

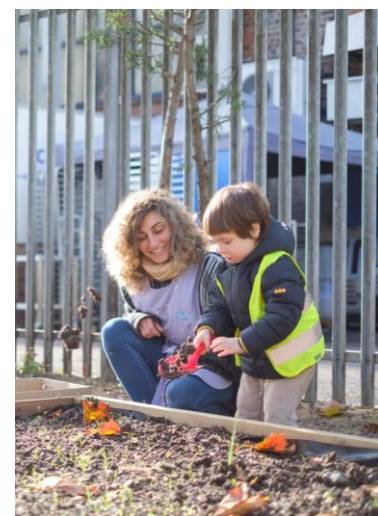
About our Community and Business Funds
