## What we are doing

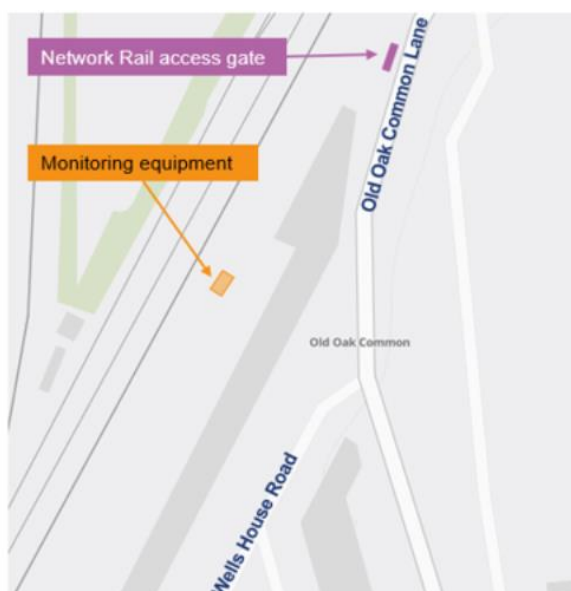
Between **Monday 15 September and Friday 19 September 2025, for one day only**, we will be installing additional ground monitoring equipment.

The works will be completed on the Network Rail land behind 163 Wells House Road.

## How this may affect you

We will be using hand tools, and you may notice some noise and vibration during these works. You may also notice workers in the area carrying equipment to the works location.
