High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To support ongoing preparations for the construction of the HS2 railway, traffic management will be introduced on Gilson Road to enable upcoming works on the Water Orton Viaducts. These works are essential to safely construct the viaducts that will span across Gilson Road and the M42.

As part of the preparatory activity ahead of the long-term traffic management, temporary two-way traffic lights will be installed at the northern end of Gilson Road

When the work will take place

To complete these works safely we will install temporary traffic signals on Gilson Road from Tuesday 26 August and will remain in place until Monday 8 September 2025. The traffic lights will be in place 24 hours a day, 7 days a week, for the duration of these works.

These traffic lights will be supervised from 7:30am to 6:00pm each weekday.

Temporary traffic lights will be in place on Gilson Road from 9:30am Tuesday 26 August until 8pm on Monday 8 September 2025.
