High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing


As part of ongoing preparations for the construction of the HS2 railway, long-term traffic management will be introduced on Gilson Road to support upcoming works on the M42 North Water Orton Viaducts. These works are critical to safely construct the viaducts that will span across Gilson Road. To facilitate this, a safety barrier will be installed along the carriageway, reducing the road to a single lane. To ensure the safety of both road users and our workforce, two-way temporary traffic lights will be in place to manage the flow of traffic through the narrowed section.

When the work will take place

The long-term traffic lights will be installed at 6am on Tuesday 9 September 2025 and will stay in place for two years, September 2027. The traffic lights will 24 hours a day, seven days a week.
