High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

From **Monday 8 to Wednesday 10 September 2025**, we will be carrying out a trial hole survey in front of the garages on Badminton Close. This is to find out more about the ground conditions.

We will cut the concrete slab using a petrol saw and break the concrete with a handheld concrete breaker. We will use handheld tools to excavate the trial hole.

Once the survey has been completed, the trial hole will be backfilled, and the concrete slab will be reinstated.

How this may affect you

You may hear some construction noise. We will use noise reducing barriers where possible.

Access to the garages will be maintained
