What are we doing?

In Autumn 2025, we will be constructing a new entrance from the Wendover Bypass for site vehicles to enter the Wendover green tunnel compound.

Prior to the construction of the entrance, we are required to complete a survey of the road. In order to complete the survey safely, there will be a lane closure of the northbound lane with two-way traffic management.

To reduce impact on road users, this traffic management will be in operation at off-peak times.

When will these works take place?

Friday 22 August (8:30pm) - Saturday 23 August 2025 (5:30am)

These dates may be subject to change due to circumstances outside of our control but works will be completed in or around the set timeframes.

Should our works be completed earlier than anticipated, we will commit to removing the traffic management upon completion.


