Drummond Street Hoarding Change

To support gas replacement works starting Monday, 18 August 2025, the hoardings at the end of Drummond Street will be extended further into the road.

Key Details:

- Hoarding Move Date: Monday, 4 August 2025
- Time: Between 10:00 PM and 5:00 AM
- Duration: Up to 5 nights to complete
- Pedestrian Access: Will always be maintained to and from Euston Station



Please refer to the diagram above for the approximate new location of the hoarding.

We understand that construction activity can be disruptive for those living and working nearby. While some disturbance is unfortunately unavoidable, we are committed to minimising noise and completing the works as efficiently as possible.
