



Notice of temporary traffic lights and overnight closures of Long Itchington Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are progressing construction of Fosse Way Overbridge and the new road realignment, including preparing and completing utility diversion and reconnection works. To do this safely, we will install temporary traffic lights and overnight closures of Long Itchington Road.

When the works will take place

The works will be carried out in two phases:

Phase one: Monday 29 September to Friday 3 October 2025. Overnight road closure from 7pm to 6am and temporary multi-way traffic lights from 6am to 7pm. A fully signposted diversion will be in place. Please see map 1 on page 2.

Phase two: Monday 13 October to Friday 17 October 2025. Temporary **multi-way traffic lights 24/7**. Please see location map on page 2.

What to expect

You may notice increased construction activity along the public highway and experience some disruption to travel times. Please allow enough time for your journeys. Access for pedestrians and cyclists will be maintained throughout the works.

Duration of works

Phase one: Monday 29 September to Friday 3 October 2025
6am – 7pm temporary multi-way traffic lights
7pm – 6am overnight road closures with diversion route

Phase two: Monday 13 October to Friday 17 October 2025
24/7 temporary multi-way traffic lights

Access for cyclists and pedestrians will be maintained

Some disruption to your journey time

Our workforce may be on site one hour before and one hour after to set up and secure our equipment

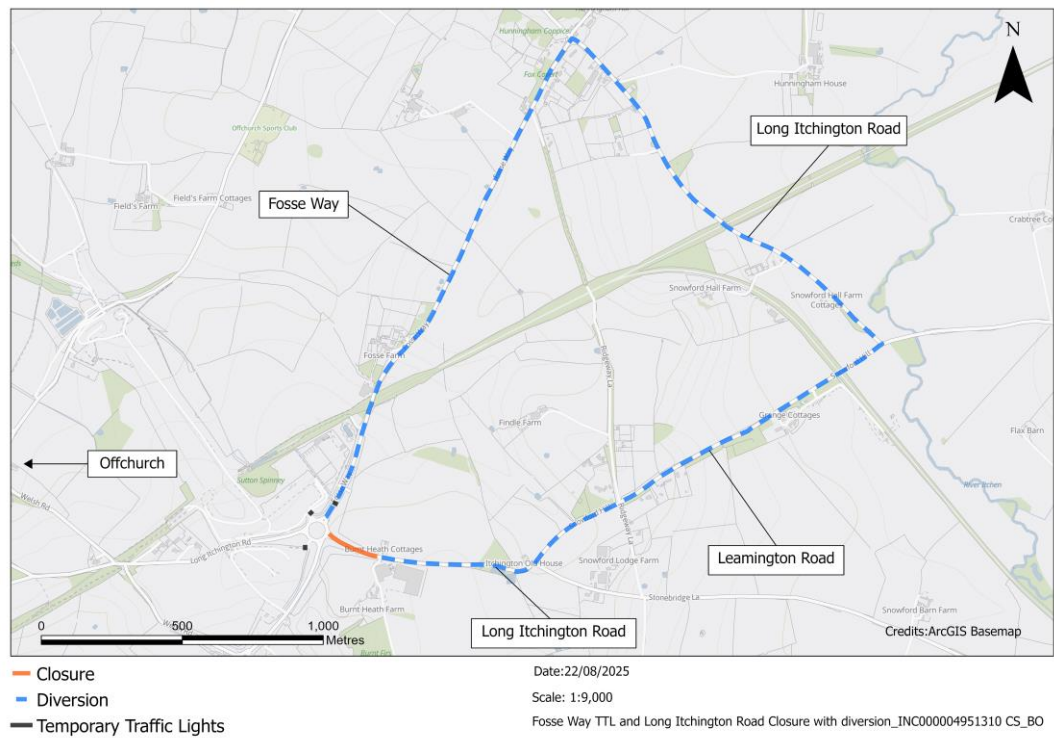
The diversion route and location of traffic lights

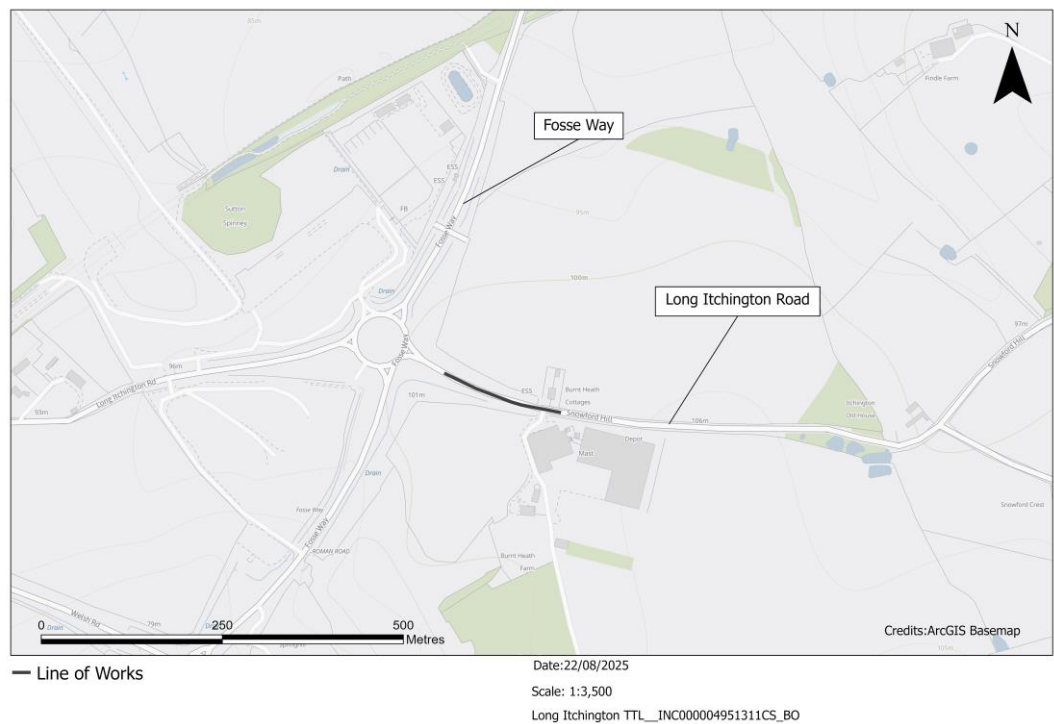

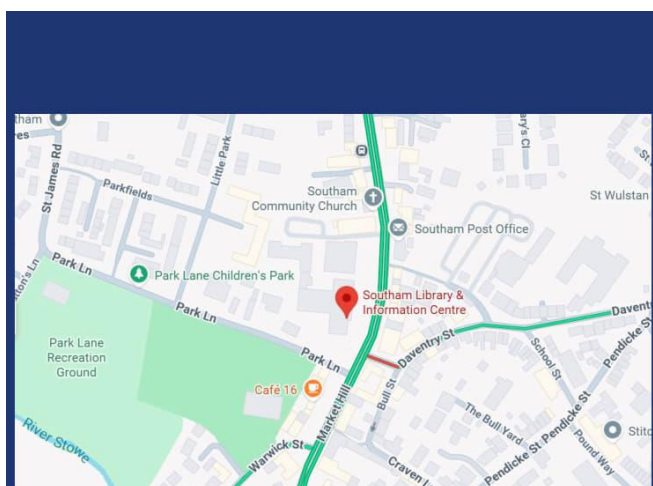
