High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

A new high-speed railway station is being built in Solihull, forming a key part of the HS2 network. Located close to the M42, A45 Coventry Road, and A446 Stonebridge Road near the NEC, Birmingham Business Park, and Birmingham Airport.

To ensure the local road network can support future traffic once the new high-speed railway and Interchange Station in Solihull are fully operational, significant improvement works have already been completed within the local area.

As part planned works within our programme, we will be carrying out a series of duct surveys overnight, on the newly constructed roundabout over the trace connecting the A452 Chester Road, A446 Stonebridge Road, and the A446 Link Road (near Melbicks Garden Centre).

To ensure our workforce can safely complete these works, overnight lane closures will be in place from Monday 1 September until Wednesday 3 September 2025 as whilst carry out our activities.

#### **Overnight lane closures:**

Each night from 8pm Monday 1 September until 6am Wednesday 3 September 2025.

These works are subject to consent.


