Temporary off-peak daytime closures on Packington Lane near Bickenhill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As part of the works to deliver Britain's new high-speed railway and the construction of the new HS2 Interchange Station in Solihull, we have been carrying out significant works along the A452 Chester Road and A446 Stonebridge Road.

As part of our planned programme of works, we will be carrying out a series of utility works on Packington Lane during September and October 2025.

To minimise disruption, works will take place on weekdays (Monday to Friday) during off-peak hours, with closures in place between 9:30am and 3:30pm. To ensure we complete our works safely the following temporary traffic management will be installed.

Packington Lane off-peak daytime closures

- Each weekday from Monday 8 September until Friday 12 September 2025 between 9.30am to 3.30pm
- Each weekday from Monday 13 October until Friday 31 October 2025 between 9.30am to 3.30pm

Access to Packington Lane via the A452 Chester Road

Access to all properties and businesses on Packington Lane will be maintained throughout these works. Access and egress via the A452 Chester Road (northbound and southbound) will remain available. Road users will be safely marshalled through the closure points during working hours on each weekday.


