High Speed Two (HS2) is the new high speed railway for Britain.

Parking bay suspensions on Mornington Terrace and Delancey Street – 15 to 26 September

From 15 September, as part of our noise insulation package, we will be completing works to selected properties along Mornington Terrace and Delancey Street. To do this safely, we will access the outside of each building using a Mobile Elevating Working Platform (MEWP).

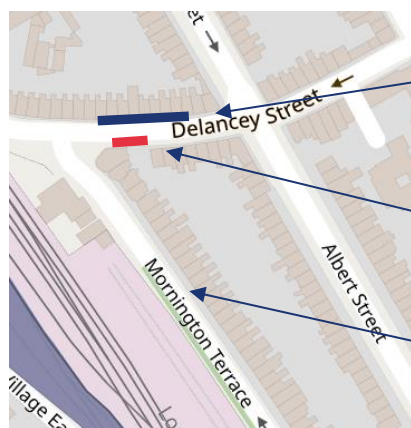
For each property being worked on, we will temporarily block off any parking bays and use a MEWP to enable the works to be carried out in a single day. We will also partially close the footpath in the location where we are working on the property and divert pedestrians.

We will try our best to block off the minimum amount of space required at a time and work systematically to minimise inconvenience to residents and vehicle users.

Bus stop suspensions on Delancey Street 22 September

As part of these works, we will suspend the bus stop on Delancey Street, north of Albert Street on 22 September. We will partially close the footpath and maintain pedestrian access at all times.
