What are we doing?

Towards the end of August there will be 3-way temporary traffic lights in place on the crossroads of Gawcott Road, Steeple Claydon to Twyford Road and West Street. These will be in place to facilitate the installation of road signs ahead of the opening of Gawcott Road on its new alignment over Perry Hill overbridge.

When will these works take place?

The traffic management will be in place from Tuesday 26 August to Thursday 28 August 2025.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Duration of works

The crossroads of Gawcott Road, Steeple Claydon to Twyford Road and West Street will be under temporary traffic management.

Tuesday 26 August until Thursday 28 August 2025, 3-way traffic lights near the entrance of the EKFB compound.

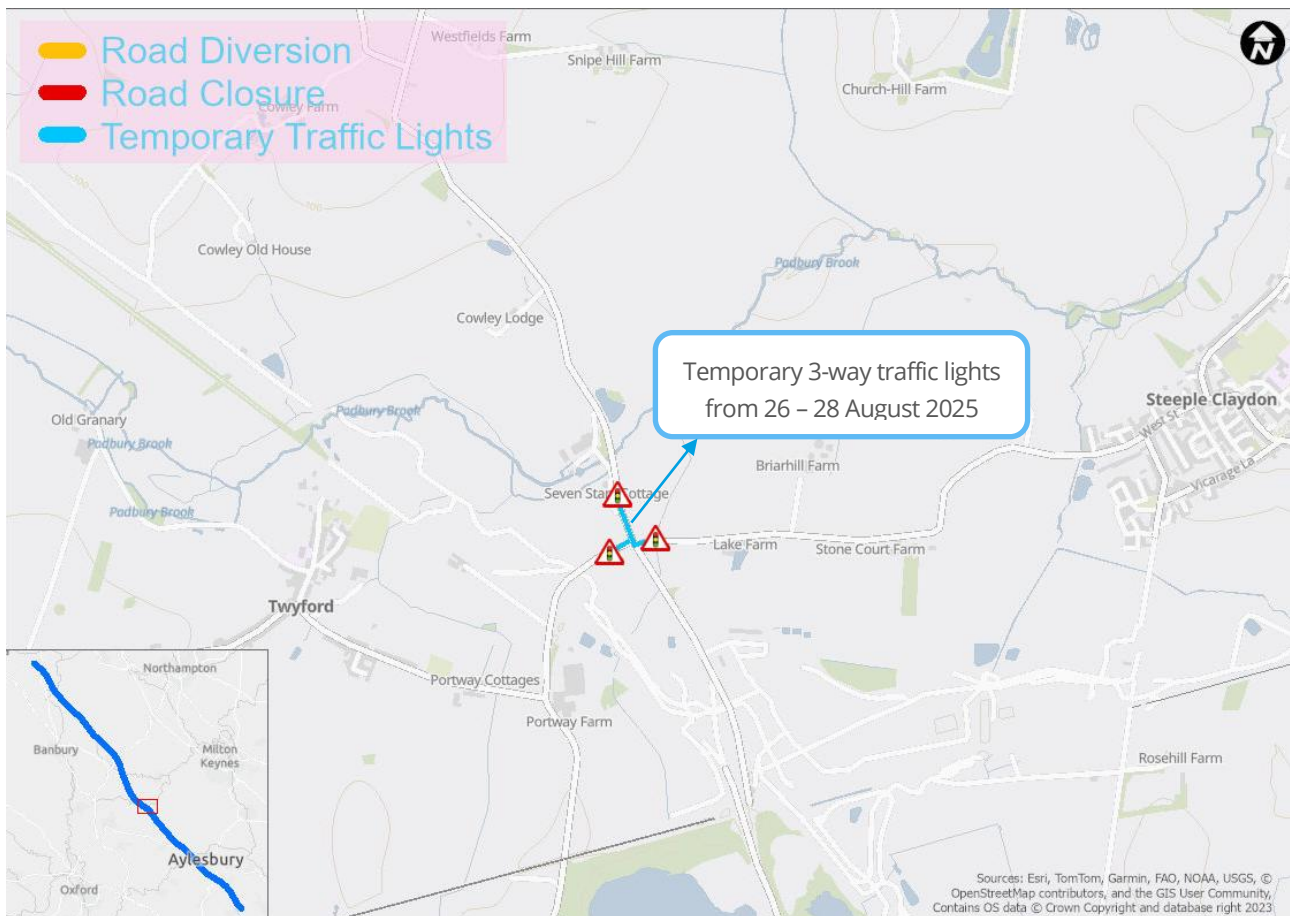
